Introduction to the various types of metal and wood door jambs and instruction on proper assembly. Shop demonstrations will include proper installation and techniques to scribe a new door to an existing jamb. Blueprints, and finish schedules, and related safety and math will also be covered.

1. Read door and hardware blueprint schedules.
2. Use specifications and manufacturer's catalogs.
3. Select proper wood jambs.
4. Select and install metal jambs.
