SCOPE OF COURSE:

This course provides the student with an opportunity to gain practical work experience within the legal field. The student will complete 120 hours of work at the internship site and attend three seminars during the semester that will focus on transitioning to the work force.

SPECIFIC COURSE OBJECTIVES: Successful students will:

1. Gain hands-on experience in a law office or other appropriate law-related work environment
2. Apply classroom skills and knowledge in an actual work setting, to enhance professionalism.
3. Learn to interact effectively with supervisors, co-workers, and clients as part of the legal team.
4. Demonstrate an understanding of attitudes and work habits that ensure a successful career.
5. Develop skills and experience in conducting a job search, including identification of career goals, resume preparation, interviewing and gathering information on prospective employers.

CONTENT IN TERMS OF SPECIFIC BODY OF KNOWLEDGE:

Students will complete the following competencies and specific goals set-forth in their “Goals Statement” of individual learning objectives and:

1. Demonstrate practical understanding of the organizational structure and functions of the job-site
2. Learn to manage time effectively
3. Develop a first hand understanding of law related office functions, i.e. internal systems, timekeeping, billing, and file management, etc.
