SCOPE OF COURSE:

Contemporary legal issues will be explored by leading experts in the field via TV broadcasts. Seminars will be conducted for the purpose of further developing legal issues and completing a research project. Students will be encouraged to submit research projects to AAFPE for publication in the American Association for Paralegal Education Law Journal. This course will be team taught to maximize individual student contact. This capstone course focuses on advanced legal writing, analysis and research.

SPECIFIC COURSE OBJECTIVES: Successful students will

1. apply advanced legal research skills;

2. apply advanced analysis and writing skills;
3. identify and prepare a research strategy;
4. synthesize cases and authorities;
5. prepare a legal memorandum draft and final document.

CONTENT IN TERMS OF SPECIFIC BODY OF KNOWLEDGE:

1. Role of the paralegal in legal writing and research.
2. Briefing and synthesizing cases.
3. Research plan and strategy.
4. Outlining and organizing a memorandum.
5. Refining legal issues.
6. Writing and presenting the legal memorandum.

REQUIRED WRITING: A legal memorandum, case briefs, and research mythologies typically several pages in length.

In addition to studying textbook assignments, reviewing lecture notes and required writings, students will view TV broadcasts.
