Announcements of Faculty Senate Appointed Positions:

Pam McDonough reported that members of the Faculty Council have discussed how to ensure that announcements for positions with reassigned time list all the responsibilities of a position. Effective immediately, announcements for positions with reassigned time will include information about all the duties that are part of that position, including information on required committee memberships. These more detailed announcements will help interested faculty members determine if their schedule will allow the commitment required for the position.

Academic Calendar Workgroup:

Teresa Laughlin commented that the current membership of the Academic Calendar Workgroup includes approximately 20 members, and the number seems to be increasing. There has been concern expressed of the possible difficulties of such a large group reaching consensus, and because the academic calendar is a working conditions issue and subject to bargaining, the PFF may discuss it with some possible recommendations brought to the workgroup for its input.

Lengthy discussion occurred on the document, particularly the membership structure on the first and second-level selection committees and the role of the compliance officer and the observer.

On another issue, Senators discussed potential concerns about teaching demonstrations on the second level and agreed that evaluating teaching and selecting second level candidates is the province of the faculty.

ACCJC's Committee on Substantive Change requires a formal review process for programs and courses that constitute 50% or more of a program, degree, or certificate, including general education requirements, through a distance mode, electronic delivery, or correspondence education. There are fees to submit the reviews and revisions. The purpose is to provide assurance of institutional quality to the public and to maintain Title IV financial aid funds for students of the institution. We have models of reports that have been approved, which are around 50 pages long.

2. Authentication and Authorization

Significant issues discusses at the state and regional level regarding online students in particular. While accreditation and system offices are really looking for institutions and diploma mills defrauding the system to collect student loan money, etc., everyone is now facing rigorous standards and scrutiny.
