I. **Technical Corrections** – **Action** The following course requisites need to be updated to reflect the discipline change from AT (Automotive Technology) to AB (AutoBody):

AB 110 – the prerequisite needs to be changed to AB 50 (it is currently AT 50) AB 51 – the recommended prep needs to be changed to AB 50 (it is currently AT 50) AB 56 – the recommended prep needs to be changed to AB 55 (it is currently AT 55) AT 155 - the prerequisite needs to be changed to AB 50 (it is currently AT 50)

Faculty Hiring Processes:

Barb Kelber shared the most recent draft version of the Faculty Hiring Policy on the overhead. She noted the changes being proposed as a result of her recent meeting with members of Human Resources (HR). After lengthy discussion, Senate members recommended some minor changes to the wording, particularly relating to the procedure of submitting applications, equivalency, and hiring committee membership duties and responsibilities.

This item will remain on the agenda for further discussion at next week's meeting.

Area D Meeting:

Greg Larson reminded Senate members that he would be attending the Academic Senate's Spring Session on April 9-11. Senators discussed each Resolution as it was shared on the overhead and agreed on whether an Aye or Nay vote was appropriate.

Larson asked Senate members to review the packet of Resolutions and provide additional input prior to Saturday's voting on April 11, 2015.

Articulation Officer Position:

Greg Larson informed Senate members that a faculty member has expressed interest in filling the Articulation Officer position on a temporary basis.

Senators reiterated that Articulation Officer is and always has been a faculty position; but is now in need of a formal structure and definition. Because the same faculty member held the position for over 15 years it was never discussed or addressed. There is a need to fill the position on a permanent basis and it may be helpful to periodically send out a call until it is filled.

Contracts with Outside Vendors:

Senate members discussed the district's current relationship with outside vendors such as Follett and Aramark. There were questions raised several months ago regarding how those partnerships are sought and approved and who oversees the process. In discussing this issue, Senate members were unsure how the process works and if it is or should be a campus-wide decision. This is not necessarily an initiative to change anything, but just a desire to have an expanded conversation with input from all who are impacted by these decisions.

This item will remain on the agenda for further discussion at next week's meeting.
