Brief discussion followed on other interim dean positions, search committees, and current status. It was also mentioned that AP 7120 will return to the Policies and Procedures committee in September for further revision, and the language on failed searches will be examined.

Information:

Greg Larson informed Senators of Governing Board action at their meeting on July 14th, when they pulled a faculty step placement item from the consent calendar due to questions about the faculty member's equivalency for the position. The faculty member has already been hired by the district, but the Board plans to revisit the equivalency issue at their next meeting. President Larson reminded Governing Board President Halcon about the role of the Governing Board in that it "relies primarily on" relationships with the Senate, and the fact that faculty equivalency is the purview of the faculty. Further discussion occurred among Senators about concerns with this action of the Governing Board. The Senate will revisit this issue in the fall.
