Rocco Versaci read the following statement for inclusion in the minutes:

As part of my Curriculum report, I would like to address some comments that were made at the November 6, 2013 Curriculum Committee meeting. These comments focused on a Senate matter and should have rightly been made here, so I'm going to respond to them here. Specifically, Monika Brannick claimed that even though the Senate resolution regarding the ACCJC passed unanimously, "several senators" told her that they did not support it. Like everyone else, I have no way of knowing how accurate this claim might be because there's no way to verify the content and tone of conversations that may or may not have taken place. Nevertheless, this claim was presented with certainty, so for the sake of argument, I'll take it at its word.

We strive to help our students embrace critical thinking, not simply as an intellectual exercise but to empower them to develop and share their voice in the larger dialogues that matter to them. As faculty and as senators, we need to lead by example. Serving on the Faculty Senate is not a vanity job; when you take a seat at this table, you are obligated to deliberate carefully, to weigh evidence and argument, and to voice your concerns, questions, and opinions. The Senate only functions when all senators embrace this obligation. If people serving on this body do not share their views simply because those views may fall in the perceived minority, then they are performing a gross disservice to what the Senate stands for and to everyone that the Senate represents. If someone chooses to silence themselves in this manner, then I would suggest that that individual find another place and manner in which to serve Palomar College.

In addition – and again, for the sake of my comments, I'm assuming the accuracy of the claim made at the Curriculum meeting – silencing yourself is bad enough, but to then intimate to someone who was not present at the debate that you were somehow "silenced" is truly bad form. For one thing, it shifts accountability by replacing one's lack of conviction with a conveniently "oppressive" majority. But also, it allows someone who disagrees with a democratic decision to claim authority in hearsay in an attempt to undermine the very important work that we do here on behalf of faculty, students, and our academic community.

TERB: Revision of Forms:

Barb Kelber provided an overview of her work on the writing team for Standard 3A (Resources) for the Accreditation Report, focusing on the evaluations component of the standard. She shared information from the ACCJC's website on the overhead and noted that members of the Tenure & Evaluations Review Board (TERB) are carefully reviewing the information which the ACCJC recommends including in the Evaluation Review Report for full-time teaching faculty. Currently, the TERB website includes

documents for the Part-Time Review Report, with a supplement for the department chair to fill out. The supplement includes a question relating to the part-time faculty member's communication with the department, as well as a yes or no question asking if the faculty member participates appropriately in the development and assessment of student learning outcomes in accordance with department guidelines. This supplement was added as a way to foreground student learning outcomes while maintaining department autonomy in relation to student learning outcomes. After the part-time evaluation revision was completed, the full-time counseling faculty and the full-time librarian faculty revised their forms to include the same question about student learning outcomes. Members of TERB are now beginning work on reviewing the full-time teaching faculty Review Report Form, as it has not been revised since before the last Accreditation site visit in 2009. The question currently on the full-time teaching faculty form asks whether the instructor establishes appropriate learning outcomes for the course and assesses for students' learning of those outcomes. TERB is discussing amending the question on the Review Report Form to provide consistent wording for all three faculty groups.

Kelber shared additional information from the Accreditation web site on Standard 3AC, "Faculty and others directly responsible for student progress toward achieving stated student learning outcomes have, as a component of their evaluation, effectiveness in producing those learning outcomes." She stated that members of TERB are looking at what other schools which are in compliance are doing as they move forward in the process, as well as opening up the issue for discussion campus-wide. There is also discussion of possibly amending the Self Evaluation Form, which might ask faculty members to reflect on how they address Student Learning Outcomes. Kelber stated the need for a faculty-driven process through the Senate, TERB, and the Negotiations Advisory Council.

Senators discussed the impact on part-time faculty members, who may not be as familiar with the process. Barb Kelber noted that she would be offering some Professional Development Training for both full and part-time faculty members on the new forms as well as the evaluation process and hopes that these elements of evaluation are being addressed at the department-level as well. This item will remain on the agenda for further discussion at next week's meeting.

Student Success
Task Force
Recommendations:

Greg Larson reported that Vice Presidents Cuaron and Gonzalez will be attending next week's Senate meeting to discuss their plans to form a work group to oversee the implementation of certain Student Success Task Force recommendations that relate to student success. Senate members noted the revival of the Faculty Advisory Board and the need for the two groups to work collaboratively.

Policies & Procedures:

Barb Kelber provided copies of the Informal Grievance/Complaint Resolution Chart for AP 5530, Students Rights & Grievances. The chart, which shows the process for both first-level and second-level resolution of various grievances, is being revised. Kelber shared AP5530 on the overhead; this policy provides the process for a formal grievance if no resolution is found on the first two levels. Discussion followed on the procedure and the resolution chart.

Kelber also shared AP 2410, Authority & Administrative Procedures, on the overhead. Kelber referenced the proposed changes to the document, and Senators noted the addition of much more wording resulting in a narrower scope. Senators were concerned that the new wording does not allow individuals to bring forward resolutions or proposed

changes. It also omits the term "College Community," thereby omitting PFF, CCE, and other groups.

Kelber also shared AP 7120, Recruitment & Hiring, on the overhead. She noted some of the changes in the document, and brief discussion followed. This item will be brought back for further discussion at next week's meeting.

Learning Outcomes

Council:

Greg Larson stated that at next week's meeting Wendy Nelson and Marty Furch will be bringing forward a GE/ILO Report, as well as discussing new rubrics proposed for assessing GE/ILOs.

Strategic Planning

Council:

Reporting on the recent Strategic Planning Council meeting, Teresa Laughlin indicated that the district is low on enrollment, but will meet the CAP.

Palomar Faculty

Federation:

Jackie Martin Clement stated that the Palomar Faculty Federation has a new Administrative Assistant, Amy Hlavaty, and also noted that the group now has an off-campus space to hold meetings and other events.

Academic Technology

Committee:

Lillian Payn reported that course shells for spring semester are now in Blackboard and instructors may begin posting content in them.
