This week, Monika Brannick provided a recent version on the overhead and additional suggestions were agreed upon to provide clarity. An updated version will be provided at next week's meeting.

Statewide Academic Senate Plenary Session:

Monika Brannick and Greg Larson attended the fall session of the Statewide Academic Senate meeting held in San Diego November 3-5. Brannick indicated that the two big issues were repeatability of courses and the Student Success Task Force draft recommendations.

Student Success Task Force Draft Recommendations:

At the recent Statewide Academic Senate meeting, members of the Student Success Task Force (SSTF), Chancellor Jack Scott, Vice Chancellor Barry Russell, Manuel Baca (Board of Governors member), Richard Hanson (Faculty Foothill College), Jane Patton (Past President of the Academic Senate), Melinda Nish (CCCIO Executive Board, Vice President, Instruction, Orange Coast College), and Constance Carroll (Chancellor San Diego Community College District) presented the draft recommendations and answered questions. This session was videotaped, and you may watch it using the following link: http://www.youtube.com/watch?v=-LfDzAH82pw. At its meeting, the Statewide Academic Senate assumed the position of taking the lead in how implementation of these recommendations should occur. Monika Brannick added that the Faculty Senate may want to consider the formation of a task force, whose members would look at the SSFT's recommendations and determine which Palomar already has in place and how to implement others should they be adopted by the Board of Governors. This item will be brought back for further discussion at next week's meeting.

Repetition and Withdrawals from Credit Courses:

Over the past few meetings, there has been discussion on new Title 5 regulations with regard to repetition of credit courses. The newly adopted regulations limit the number of times a community college district can receive apportionment for students who enroll in the same credit course multiple times. The district will receive apportionment for three attempts only, with certain limited exceptions. These changes have been in effect since October 12, 2011, and must be implemented by the 2012 summer session.

Discussion took place on the importance of informing students of these Title 5 changes. Although many faculty members have already announced the changes in their classes, Senators agreed that the district should formally notify students. Monika Brannick indicated that she would discuss this with President Deegan and Vice President Cuaron at their upcoming meeting.
