CALL TO ORDER: The meeting was called to order by the president, Monika Brannick, at 2:00 p.m., in

Room SU-30.

Approval of Minutes:

Motion 1 MSC Bishop, Chau: Faculty Senate approval of the minutes of February 8, 2010, as

presented. The motion carried.

Public Comments: Tracy Emblem, Candidate for United States Congress, California's 50th District,

announced her entry into the race. Emblem is challenging Francine Busby for the

Democratic candidacy. Brian Bilbray currently holds the seat.

Announcements: Monika Brannick announced that with no objection from Senate members, Curriculum

items would no longer be photocopied and distributed at Senate meetings. Senators receive the information electronically, and the information is included in the minutes of

the meeting in which they are presented for discussion.

Monika Brannick announced that every two years the Academic Senate for California

Community Colleges conducts a review of the Disciplines List. It is time once again to begin the formal review of the List, which establishes the minimum qualifications for the faculty of California Community Colleges. Information will be sent to Department Chairs and Directors for their review. More information can be obtained by visiting the

Statewide Academic Senate's website.

Agenda Changes: Due to today's guests addressing items on the Agenda, some Information items on the

Agenda will be discussed first, followed by Action items, then Reports, if time permits.

Other: Barb Kelber and Senate members expressed their gratitude to the members of the

Palomar Faculty Federation (PFF) for all of their work on recent contract negotiations.

Use of Trac Dat in

Evaluations: Barb Kelber indicated that per the recommendation of the Tenure & Evaluations Review

Board (TERB) and the concerns of the Faculty Senate, the PFF negotiated the following

terms in the contract:

17.9 Trac Dat Software

"The District's acquisition of TracDat software is to support the District's ongoing effort to meet accreditation standards. The District will not use TracDat or the data collected by TracDat for faculty evaluation or discipline."

Senators expressed their support of the statement.

Proposed Code of Ethics:

Barb Kelber stated that the Proposed Code of Ethics currently being reviewed in the Policies and Procedures task force, will not apply to faculty, as the Faculty Senate Constitution currently outlines a Code of Ethics for The Faculty. The district has accommodated the request for exemption in a letter written to the PFF, acknowledging the primacy of the Faculty Constitution in cases related to faculty.

Program Review and Planning Document:

Senators received electronic copies of the Program Review and Planning (PRP) document. The changes in how data is presented on student achievement, separating Retention and Success rates for Non-distance education and Distance education were made with regard to Recommendation # 3 in the Accreditation report. Also, the Distance Learning Manual states under "Evaluation and Assessment":... the institution evaluates the educational effectiveness of electronically delivered course work, including assessments of students learning outcomes, student retention, and student and faculty satisfaction.

Monika Brannick noted that the document was developed in the Instructional Planning Council and reviewed by the Chairs and Directors. Upon approval by the Senate, the document will be used in the PRP process for 2011-12. After brief discussion, Senators expressed their support for the change, and Brannick will notify Vice President Cuaron of the Senate's approval.

Blended Courses:

Part-time faculty member, Pat Lupica, provided the following proposal for the expansion of "Blended Course" offerings:

Topic: A college level strategy for the creation and introduction of blended courses.

"Blended courses" defined as: A class that is half-time in class and half time on-line. For example: a T/Th class meets face-to-face on Tuesday and on-line for the balance of time.

Benefits:

- Better prepares students for what is being practiced in business.
- Better learning experience as students can revisit content on-line.
- Establishes a platform for continuous process improvements; if people are actively using the tools, it is likely that more recommendations will be made on a regular basis.
- Develop stronger partnerships with publishers and technology providers for on-line content and tools
- Reduce costs as fewer students will be on campus at any given time (depending on the level of
 incorporation of a blended or hybrid program).
- Strengthen faculty on-line/technology skill level and could actually enrich the teaching experience.

Challenges/possible solutions:

- Resistance by faculty standardization and training would help here. Standardization via
 shells/templates for specific classes pre setup with interactive video, audio, games, exams, etc.,
 which can be modified by the instructor the key here is modification vs. creation- like a do it
 yourself kit. The on-line component could also be used as a tool to capture learning outcomes, and
 standardize the format and content (to some degree) for which a specific course is presented.
- Training/Support: Training: basic navigation training required, but most faculty have a basic knowledge of Blackboard or WebCT. Support: while some additional support may be required initially, support resources already exist.
- Resistance by students and faculty standardization (as mentioned above) could help students so
 they know where to look for content, materials, etc.; perhaps more importantly, the face-to-face
 component could help with students' technology/navigation issues, which can feel like a lifeline to
 someone who is not familiar with on-line tools and communication.

After some discussion, Senators agreed that Lupica should initially approach her department with these recommendations, and with their support, as well as potential input from the Academic Technology Committee, the proposal could eventually be sent to the Curriculum Committee. There was also discussion regarding Palomar's current offering of hybrid courses. One Senator noted that a more beneficial trend for students would move the college away from more distance (online) course offerings and focus on more courses requiring them to be present in the classroom with instructors and fellow students. Several senators agreed, while others pointed out that expanded hybrid (or "blended") courses respond to the need for instruction in information systems and technology. They noted that a strictly hybrid course (requiring that, for instance, students in a Mon/Wed class meet on campus only on Monday) would satisfy this instructional need and would also increase flexibility in scheduling, creating dramatically increased room availability.

Senators commended Lupica for her work on the proposal and encouraged her to take it to her department to begin any formal curriculum development.

Spain Study Abroad Program 2010:

Martha Evans provided the following information to Senators on the Spain Study Abroad Program 2010:

The Spain Study Abroad Program has been offered through Palomar College for almost 25 yrs and is considered to be a forerunner in the study abroad programs in higher education. It is without question an outstanding program.

Students live with a Spanish family for four weeks in Salamanca, Spain, a city which houses the oldest and most prestigious western European university, dating back to the 1200's.

-Students take part in the daily life of Spain and learn what it means to be a Spaniard.

- Students attend a renowned language institute for four weeks, four hours a day.
- Students take excursions to World Heritage Cities (Madrid, Toledo, Barcelona, Segovia, Avila.)

An immersion program in the target language and culture is absolutely the best way to learn a language!!!

History:

- The Spain Study Abroad Credit Program under the World Languages Department was indefinitely cancelled after the beginning of the Spring 2010 semester by Palomar Administration after the program had been promoted and deposit checks submitted by students.
- Due to this decision, we decided to offer this invaluable program under the auspices of Workforce/Contract Education.
- <u>As such, our Spain Program WILL NOT BE COMPETING with any program in World Languages</u> since the program no longer exists in World Languages.
- We are aware that Workforce/Contract Education courses usually are not offered for transferable credit.
- The Spain Study Abroad Program has always been offered for credit.
- We are URGENTLY requesting that the Senate permit that credit be granted to those students participating in the Spain Study Abroad Program this year.
- It is our intention and commitment to reinstate this program under the World Languages Department as soon
 as the Administration allows it to be offered.

Need for credit:

- Students can complete part of their language requirement while attending the program.
- Students grow tremendously emotionally by their exposure to another culture and language.
- Fluency in the language increases greatly. (In a classroom this does not happen.)
- Students attend a renowned language institute for four weeks, four hours a day.
- -Students are tested upon arrival as to their language ability and placed in classes accordingly.
- -The classes are small and divided into conversation and grammar components.

- Students participate in excursions to numerous educational spots of interest, including the Prado Museum and the Reina Sofía Museum, -They travel to and spend time in World Heritage Cities: Segovia, Toledo, Barcelona, Salamanca, and Madrid.

o Students should receive credit for this undertaking!

Experience in the program:

Changes and affects students' lives in a most positive manner; their outlook on life changes.

Causes students to grow emotionally, become more tolerant of other cultures, and learn to accept others for who they are and what they believe.

Causes students to begin to see themselves as others see them—sometimes a rude awakening!

Makes history come alive as we cross Roman bridges, visit Roman ruins and medieval walled cities, learn about the history of the Christians, Moors, and Jews who co-inhabited Spain and learn to appreciate their literary and artistic contributions.

We ask that the Senate permit that credit be given to students participating in this program this year under the Workforce/Contract Education Division so that the program may continue to be viable. We strongly feel and professionally believe that the Spain Study Abroad Program is one of the most valuable educational programs offered through Palomar.

Martha Evans and Eduardo Peixoto responded to Senators' questions regarding the history of the Study Abroad program, as well as recent changes as a result of budget cuts and cancelled classes. Many students have already enrolled and provided monetary deposits, and Evans and Peixoto have applied for a grant through the Palomar College Foundation to pay faculty salaries. If the grant cannot be obtained, there would have to be an increase in fees collected from students enrolling in the course. Evans and Piexoto absolutely hope to avoid this necessity.

Senator Studinka noted that the Workforce and Community Development (WCD) Task Force is discussing this matter, and there are no issues limiting the proposal in Title 5, though Dean Wilma Owens and Shannon Lienhart continue to gather information. Studinka pointed out that the fee to be collected from students has already been printed in the catalog, hence the request for the Senate's support of the process going forward, utilizing grant funds. One concern expressed involves the potential illegality of offering to the public a course that is not collecting FTEs, and Senators noted that courses offered through WCD are not offered for credit, and have not been transferrable, specifically because the compensation scheme is different and the grading/evaluative process should remain within the traditional structures of articulated courses and curriculum development. Lengthy discussion followed, and Senators expressed serious concern regarding two additional issues: that the cancellation of the Study Abroad program occurred through a unilateral decision at the administrative level, and that there is danger in the potential precedent of the use of Palomar Foundation grant funds for faculty salaries.

Motion 2

MSC Bishop, Chau: To move Information item E, Spain Study Abroad Program 2010, to Action. The motion carried.

Motion 3

MS Bishop, Furch: Faculty Senate support for the Spain Study Abroad Program 2010 to be offered as a for-credit course through the Workforce and Community Development program. The motion was not voted on.

There was some discussion on the motion, and it was noted that it was brought forward only to offer the Senate's support of the program being offered for credit and only on a one-time basis. The motion implies acknowledgement of the unique, extenuating circumstances, as funds have already been collected from several students. The situation, as a consequence, could warrant the Senate's support.

Additional discussion followed, and a Senator suggested that the Senate could make their gesture of support more concise by bringing forward a resolution outlining their support for the course offering in this single circumstance due to the college's current financial crisis. Another Senator voiced support of Evans' and Peixoto's intentions and agreed with all the members of the Senate with regard to the value of the Study Abroad program for students and for the college, particularly for the part it plays in demonstrating the college's commitment to General Education Learning Outcomes and program review.

One Senator expressed support along the same lines, but stressed the precedent-setting nature of the proposal and the Senate's potential support. She recalled other suggestions which have to come to the Senate for additional courses to be offered through WCD, courses in anatomy, for instance, which were sought to alleviate pressures in programs and to respond to demand for specific courses. These proposals were immediately rejected by the Senate, recognized as examples of a dangerous precedent in which courses in much demand would be "contracted out" to WCD, offered outside the compensation structures attached to articulated, for-credit courses.

Senators agreed that the Study Abroad Program should be restored to the World Languages Department and offered as it has traditionally been. Evans and Peixoto concurred, observing that the return of the program to their department and to its previous status in curriculum would be the ideal resolution, but they are still faced with the unique circumstance in which students have already paid for a program scheduled to begin at the end of the spring semester.

Barb Kelber and Bruce Bishop volunteered to draft a statement of support by the Senate, in consultation with the World Languages Department, in order to articulate the Senate's position: The entire Study Abroad Program should be restored to the World Languages Department, and the Senate hopes this will occur as soon as possible. Meanwhile, the Spain Study Abroad Program should be temporarily identified as returning to its previous status in terms of curriculum. It should be treated as a single and unique case, given the extenuating circumstance in which students have already paid for the program and have a reasonable expectation that the course will be offered for credit. In light of the unilateral and unexpected action which resulted in these class cancellations, these two teachers, in this single case, should be paid by the District in the traditional method.

The motion was postponed and a draft statement of support will be brought forward to next week's meeting.

Service Learning Workgroup:

Monika Brannick reminded Senators of discussion held at the February 8, Faculty Senate meeting regarding the Service Learning Working Group and its formation under the leadership of Kathy Grove. The group worked directly under the Learning Outcomes Council, and at that time there was agreement within the Senate that the formation should start out as a working group and later be formed into the committee. Kathy Grove was directed by the Senate to obtain input from the other members of the Service Learning Workgroup. Information was to be provided to the Senate to offer direction regarding how the committee should be structured.

Brannick stated that after further discussion with Grove on this issue and providing information that if formed as a Faculty Senate committee, there must be Faculty Senate representation, Grove indicated that the group has only been meeting approximately twice a semester. Grove also reported that other colleges and universities, including Mira Costa, provide a Service Learning office with a fulltime staff member to deal with issues relating to Service Learning. Palomar's Service Learning Coordinator currently receives 20% release time, which will have to be reassessed in a couple of years, as this funding is possible only while Palomar College is not chairing the North County Higher Education Alliance (NCHEA). Currently, 12 faculty members are actively participating in Service Learning, and 75 additional faculty have expressed interest in participating, as well as many students.

After brief discussion, Senate members directed Brannick to encourage Kathy Grove to begin to gather the narrative and quantitative data necessary to bring a proposal to the District for a Service-Learning office and organization of the type described above. Marty Furch also noted that she would bring the item (and the recommendation to maintain the status quo pending a proposal for change) to the Learning Outcomes Council for their input.

Online Observation Form:

Barb Kelber reported that the Online Observation Form continues to be reviewed by the Academic Technology Committee. The workgroup in Academic Technology will discuss the issue of Universal Access and requirements for compliance with the Rehabilitation

Act. Kelber indicated that she will participate in discussions with the workgroup and bring the revised document back to the TERB for approval and to the Senate for review.

Policies & Procedures:

Monika Brannick reported that several Policies & Procedures are currently being discussed by the Policies and Procedures Task Force. The following items will be brought forward for further discussion at next week's meeting:

AP & BP 3430, Prohibition of Harassment

AP 3435, Discrimination and Harassment Investigations

Academic Honesty:

At the February 8, meeting, Senators discussed Palomar's current and proposed Academic Honesty policy. At the beginning of last semester, the Academic Standards & Practices Committee (AS&PC) was directed by the Faculty Senate to review the current policy. The issue was related to a concern regarding the legal opinion issued by the Chancellor's Office which indicates that the policy of many community colleges, including Palomar, is not in compliance with their interpretation of Ed Code. Members of the AS&PC carefully reviewed existing case law and the Chancellor's Office interpretation of Ed Code, looked at the policies and procedures of other community colleges and universities, and came to the conclusion that they do not agree with the Chancellor's Office. The Statewide Academic Senate has been asked to petition the Chancellor's Office for a review and to obtain an outside legal opinion as to whether the Chancellor's Office interpretation of Ed Code is valid. Members of AS&PC have concluded that the district should maintain the option for faculty members to fail a student for an entire course if they believe a violation involving academic dishonesty rises to the level where failure in the course is an appropriate response. The committee also suggests a process by which a student accused of violating academic honesty standards would be assured due process in the disposition of the case. At its February 8 meeting, Senators were asked to review copies provided of Palomar's existing policy on Academic Honesty Guidelines, as well as a draft created by the committee to update Palomar's current policy.

Bruce Bishop added that the committee wishes to hear input from students on this issue as well, and asked ASG Representative John Aragon if the ASG has had an opportunity to discuss it. Aragon had several questions and indicated that students have carefully read the document and are very interested in clarity and consistency in any policy of this kind.

Aragon noted that members of the ASG have requested that AS&PC chair Bruce Bishop attend an upcoming ASG meeting to provide additional information. Bishop also suggested that students interested in this issue should attend next week's Senate meeting to provide comments and to receive additional information.

One Senator also noted that an informative article on Academic Honesty appears in the current issue of *The Senate Rostrum*, published by the State Academic Senate. The link for the article is: http://www.asccc.org/Publications/Ros.htm.

Learning Outcomes Council:

Marty Furch reported that faculty can receive information on GE Outcomes by logging on to Blackboard, clicking on "Learning Outcomes," then by clicking on "GE Outcomes."

Members of the Learning Outcomes Council have amended the timeline for implementation of SLOACs for accreditation purposes. More information will be provided at next week's meeting.
