Approval of Minutes:

Monika Brannick announced that Palomar College's Committee to Combat Hate will

host an "Imagine Equality" event on Thursday, March 5, 2009, from 5:00 - 7:00 p.m. in

the Student Union.

This event is being held to rally support for overturning Proposition 8. On March 5, the California Supreme Court will hear the first oral arguments for the case to overturn Prop

8. Opponents have already made threats to remove judges who vote to repeal this

undeniably discriminatory proposition.

Learning Outcomes Council/Basic Skills:

Gary Sosa updated Senate members on the progress of the BSI/HSI Committee.

Professional Development Learning Communities Workshops continue to be held, and they have been well attended by faculty members who will be teaching in the Learning

Communities in the fall semester.

An Apple computer workshop on "Student Generated Content" was held in February, showcasing various ways to integrate student video productions into classes and to

disseminate these productions in Youtube and other video formats.

Members of the committee continue to attend conferences, and Sosa provided a brief report on his recent attendance at the National Association of Developmental Education

(NADE) Conference, which focused on assisting adult learners with educational skills.

Progress on the Teaching/Learning Center at the Escondido Center is ongoing. Construction is currently out-to-bid, and the project is running approximately a month behind schedule. Sosa anticipates that the TLC will be open in the fall semester, providing assistance in Math, Reading, English, ESL, and other subjects to be determined.

Excellence in Teaching Mini Grants:

Pam Grasso and Richard Talmo provided information on Excellence in Teaching Mini-Grants, with reference to the application form, which follows:

The Palomar College Foundation is pleased to announce the Excellence in Teaching mini-grant program. The purpose is to promote and support excellence in teaching by improving instruction and supporting faculty members' professional development as it relates to the mission and goals of Palomar College.

Any faculty member is invited to compete for mini-grants. A mini-grant up to \$1,000 is available. Only one mini- grant per calendar year can be awarded to any faculty member. Members of the Foundation's Grant Review Committee will evaluate the proposals and submit the recommended applications to the full Foundation Board for final approval.

Project proposals will be judged on the following criteria:

- The project/activity aligns itself with the mission, values and strategic goals of student success and teaching excellence.
- The project/activity promotes excellence in teaching and learning via activities related to the personal, instructional, or institutional components of professional development.
- The proposal includes evidence of instructional benefit and application for students and/or support of the professional development of faculty.
- The proposal includes a brief itemized budget outlining the use of the requested monies.
- The proposal includes a plan for reporting the results of the project to the Faculty Senate, as well as the Foundation Board (Example: a synopsis report to be presented to the Foundation Board, as well as a brief presentation to faculty, staff, and/or administrators during a scheduled faculty meeting or in-service day).

Providing clarification on a discussion held at last week's meeting regarding the addition of MATH 60 as a prerequisite for ECON 101 and ECON 102, Monika Brannick indicated that the change is in-line with the CSU system, which is also requiring MATH

60 as a prerequisite for these courses.

Academic Standards

& Practices Committee: At last week's meeting, Academic Standards and Practices Committee Chair, Bruce

Bishop, provided copies of a draft created by the committee, titled, "Consequences for

Violation of College Academic Honesty Guidelines." At that meeting, Senators reviewed the recommendations included in the document and suggested minor changes.

This week, Senate members continued this discussion, and one Senate member suggested that the committee consider following the format of the district's current Grade Dispute Policy, pointing up that one of the strengths of the Grade Dispute Policy is that it requires conflicts to be initially addressed at the department level before entering more formal proceedings.

Director of Student Affairs, Sherry Titus, expressed concern that the policy conflicts with the legal opinion issued by the Chancellor's Office on Academic Honesty issues, which advises that failing students in a course for isolated instances of cheating is not permissible, unless the weight of the assignment on which the student cheated and failed was great enough to bring the student's overall grade below passing.

Bruce Bishop noted that the legal opinion of the Chancellor's Office is its *interpretation* of Ed Code, not the law. He indicated that what the committee found in the Chancellor's opinion is that if an instructor fails a student for an isolated incidence of academic dishonesty, and the student denies wrongdoing, due process must be assured. Thus, so long as students have access to a due process procedure, instructors should retain autonomy in their decision to assign a failing grade for isolated incidences of cheating.

Lengthy discussion followed, and some Senators expressed concern with the differing perceptions of the Chancellor's Office's legal opinion as articulated by Titus and Bishop. Given the distinct ramifications of abiding either of these perceptions, the Senate needs to clearly determine the legal authority of the legal opinion of the Chancellor's Office on this issue.

Members of the Academic Standards and Practices Committee will continue to discuss this issue, and Bruce Bishop asked Sherry Titus to attend their next meeting to provide additional input.

Bishop also provided copies of a draft document from the committee on Administrative Retreat Rights. He outlined the committee's recommendations, and a brief discussion followed. This item will be brought back for Senate discussion and/or action at next week's meeting.

Motion 10

MSC Gowen, Chau: To extend the meeting until 3:35 p.m. The motion carried.

Service Pins:

At last week's meeting, Senators discussed action taken by the Faculty Senate in 2008 to support the distribution of service pins to part-time faculty members. Unfortunately, due to severe budget constraints facing the district, the practice of distributing service pins to all faculty and staff has become a point of concern.

Motion 11

MSF Bishop, O'Brien: Due to budget constraints facing the Palomar district, the Faculty Senate recommends that the practice of distributing service pins to part-time faculty be suspended for this year. The motion failed.

Senate members discussed options other than excluding one employee group.

Motion 12

MSC Bishop, Chau: The Faculty Senate supports the distribution of service pins to parttime faculty members and recommends soliciting the Palomar College Foundation to cover the cost of all service pins for the 2009 academic year. The motion carried. Faculty Senate Meeting, March 2, 2009 Page 5

Matriculation &

Transfer Committee: Members of the English department have expressed concern about the lack of fulltime

faculty representation on the Matriculation and Transfer Committee. While the English department recognizes and appreciates those part-time faculty members who wish to participate, it feels that the named positions from Math, ESL, Reading, Counseling, and English, should be fulltime faculty members to ensure continuity and currency within

those departments.

Motion 13 MSC Chau, Gowen: The Faculty Senate recommends that the named positions for

fulltime instructors on the Matriculation and Transfer Committee remain in place, and

that two part-time faculty member positions be added. The motion carried.

Homepage Class

Cancellation Link: At last week's meeting, Associated Student Government President, Robert Frederick,

shared an ASG resolution to post a link on the Palomar College homepage to notify students of single class meeting cancellations. Senators found the resolution laudable, particularly as it benefits students who commute long distances and use public

transportation.

Motion 14 MSC Morrow, Furch: The Faculty Senate endorses the creation of a link on the Palomar

College homepage to provide notification to students of single class meeting

Drinan has expressed concern that due to the upcoming maternity leave of the TERB Academic Department Assistant, the incoming coordinator will not have the assistance that he or she may need to transition into the position. As such, Drinan has agreed to serve for one additional semester in a joint appointment with the new coordinator to assist in the training process.

Brannick asked Senators to consider Drinan's offer. This item will remain on the Senate agenda for further discussion and/or action at next week's meeting.
