Distribution of Faculty Senate Assigned Time:

Senate members discussed the total amount of Faculty Senate assigned time at last week's meeting. Currently, the Senate is allotted 140%. While 80% of that amount is usually assigned to the Faculty Senate President, this year the president used only 60% because of the reassigned time he was also receiving as Curriculum Committee Co-Chair. Because of this particular situation, the Faculty Senate had an extra 20% this year which it shared with the Service Learning Coordinator, who receives 20%. Because there will be a new Curriculum Co-Chair beginning next semester, another solution for assigned time for the Service Learning Coordinator will need to be addressed by the district. Last week, Senators recommended that the matter be brought to the Vice President of Instruction by the current Service Learning Coordinator.

Academic & Professional Matter: ASG Vote to Censure:

At last week's meeting, Senators discussed the Associated Student Government's (ASG) recent action to censure a professor. The ASG recently developed a by-law to its constitution specifically granting itself powers to issue censures, and at last week's Governing Board meeting, the ASG presented two charges against a faculty member. The Senate expressed its concern with the lack of due process for the faculty member, and although the censure carries no formal consequences, the announcement was made at a public meeting and could place the faculty member's reputation into question.

This week, Senate members discussed the following Resolution, and discussion occurred on freedom of speech. ASG member Dane Thorp explained to Senate members the process utilized by the ASG in censuring a member of the faculty, and he explained that the same process would apply for a censure of a member of the staff or administration, noting that the process took over a month to complete.

Motion 4

MSC Laughlin, Moore: Whereas, the Associated Student Government conferred upon itself the ability to publicly censure faculty members; and

Whereas, the Associated Student Government's censure process does not allow due process for the faculty member accused; and

Whereas, Palomar College has in place established student grievance processes for grade disputes and other incidents; and

Whereas, in the cyber age, a faculty member's reputation can be irreparably damaged by unsubstantiated claims of unprofessional conduct;

Resolved, that the Faculty Senate opposes the Associated Student Government's practice of censure, and be it further

Resolved, that the Faculty Senate asks the Secretary of the Board of Trustees to keep the names of censured faculty members from becoming public in the posted minutes of the board.

The motion carried.

ASG member Thorp noted that there is currently not a grievance process in place for students who have an issue with a faculty member who is not teaching a class in which the student is enrolled. One Senator noted that any student could file an incident report.

Barb Kelber also noted that faculty members representing the Senate on the Policies & Procedures Committee are currently reviewing an administrative procedure on Students Rights and Grievances, and will carefully review the wording in the document to assure sufficient recourse for students.

Tutoring Workgroup Relationship to The Faculty Senate:

Greg Larson reminded Senate members of Gary Sosa's attendance at a recent Faculty Senate meeting to discuss the work of the Tutoring Workgroup and to hear input on making it a Faculty Senate Committee. The group has been meeting informally once per month for the last several years and working with Tutoring Coordinators to standardize

the way tutors are hired and trained. The goals are to maintain quality and to ensure that faculty and students are aware of tutoring services available to them.

Larson indicated that he would bring forward a Governance Structure Group Request form to next week's meeting to allow for a formal approval of the creation of this Faculty Senate Committee.

Additional Permission for Blackboard beyond The existing Instructor and Student Access:

Jackie Martin noted that there is a posting on the Academic Technology website discussion board regarding the Senate's discussion on levels of access relating to Accreditation. Lillian Payn noted that there is still uncertainty of what will be requested by Accreditation team members. She referred to incidents at two institutions where Accreditation team members enrolled (as faculty) in online classes for monitoring purposes. Palomar is anticipating, based on what has occurred at other campuses, requests for unlimited instructor and student access.

In the event that Accreditors request access to online courses, those instructors "opting in" for an Accreditation visit can request that PeopleSoft staff enroll the visitor through Visitors Access for a limited time during the visit, and the Academic Technology Resource Center can limit access in compliance with FERPA guidelines. Jackie Martin stated that there is still clarification needed on exactly which level the visitor/guest will be allowed to access, as well as the time frame in which they might do so.

MSC Albistegui-Dubois, Moore: Resolution Calling for a District Policy Regarding Privatization of Education

Whereas, Palomar College is a significant contributor to the region and state, a comprehensive community college which is a source of pride for many, and which has served hundreds of thousands of people within the largest system of public education in the world, the California Community College system; and

Whereas, Palomar's commitment to quality public education has been a hallmark of its identity for sixty-seven years, reflected in its shared mission and values; and

Whereas, public education is fundamental to the ideals of democracy and the public good; and

Whereas, our students are at the center of our work and our professional lives, as public education depends on a transaction between the public trust and each individual's potential for education, enrichment, and advancement; and

Whereas, along with every college in the California Community College system, Palomar is currently confronted by potential changes in the fundamental elements of public education, as those potential changes have taken shape in recent years at the confluence of new technologies and economic pressures; and

Whereas, the commercial and political interests which will profit from these potential changes emphasize efficiency and production models for education, promoting market-driven organization to deliver instruction and training for profit; and

Whereas, this signifies a fundamental shift in public education as we have known it here at Palomar, as we experience waves of change and pressures to conform that mirror the larger problems across the community college system statewide; and

Whereas, the emphasis on production, standardization, and efficiency drives "best practices" toward more "readable" outcomes, and the data that is offered as evidence of those outcomes drives an enormous profit for private ventures; and

Whereas, these trends threaten local design and shared governance, consequently diluting the progressive power inherent in higher education; and

Whereas, privatization refers here specifically to the shift from public or government control to private ownership and enterprise and does not refer to our valued partnerships with local business and industry in advisory councils and career development programs; and

Whereas, for-profit programs and digital delivery systems (no matter how expensive or impersonal) can be presented as in all ways equal to traditional approaches to teaching and learning in disciplines and degree programs; and

Whereas, legislation, for-profit programs, products, and trends are often promoted under the banner of "Student Success,"

Resolved, that the faculty of Palomar College will exercise its rightful role as custodians of curriculum and program development on this campus, guarding our students' interests by defending the quality of public education and the continuing role of community colleges in the goal of Student Success, and be it further

Resolved, that the faculty of Palomar College, committed to our students in the rapidly-changing landscape of higher education, shall seek the collaboration of the entire campus in actively evaluating the encroaching trends and opportunities, many of which may exploit and divert tax dollars and our students' money, whether that money comes from their own pockets or in the form of government resources, grants, or loans, and be it further

Resolved, that the faculty of Palomar College will engage in the development of a campus-wide policy intended to realize the goals of this resolution.

The motion carried.

Accreditation:

Wendy Nelson shared an updated version of the Accreditation Report on the overhead. She reviewed the recent updates to the Gainful Employment Index, the Fact Book, and Instructional Effectiveness sections. Brief discussion and a question and answer period followed.

Policies & Procedures:

Senators were provided with copies of AP 4225, Repetition of Courses. Larson noted the minor changes, which are all in-line with Title 5 wording. He asked Senators to review prior to next week's meeting.

Barb Kelber also reminded Senators of previous discussions of AP 3715, Intellectual Property. She noted that members of Academic Technology have reviewed the document, and a meeting is scheduled with Debra Doerfler on Tuesday, April 2, to incorporate some of the changes proposed. She asked for the Senate's approval in bringing the document forward at Friday's Policies & Procedures meeting. Senators expressed their support for moving the documents forward.

Position Statement Regarding MOOCs:

Lillian Payn provided copies of the following report from the Academic Technology Committee regarding MOOCs:

At Palomar College we comply with Title 5 for distance education. We evaluate our distance education courses according to specific Title 5 regulations:

- instructor-student contact
- identifying at risk students

Our approval of courses delivered via Massive Open Online Courses (MOOCs) is based on the same scrutiny of compliance with Title 5 regulations as other online courses.

Furthermore, we are concerned with the following additional issues among others that arise in high-enrollment distance education courses:

- ability of our students to learn independently
- selecting appropriate courses
- faculty involvement to determine course content, textbooks, and other learning materials
- guiding learners beyond information distribution to building knowledge through deeper and higher levels of critical thinking, problem solving, synthesis and evaluation
- completion rates (please see recent research on completion rates in MOOCs: http://www.katyjordan.com/MOOCproject.html)

We endeavor to ensure that a course delivered via a MOOC has the same content and the quality as any other face-to-face or online course at Palomar College.

Brief discussion followed on the document. This item will be brought back for further discussion and/or Action at next week's meeting.

Senators expressed dismay at the seeming centralization of the entire community college system.
