**BSI** Report:

Gary Sosa, BSI Co-Coordinator, stated that he was present at today's Senate meeting to receive guidance from the Faculty Senate on procedure and to provide an update on the progress of the Basic Skills Initiative/Hispanic Serving Institution (BSI/HSI) Committee. He reported that, in line with efforts to support tutoring on campus and at the Teaching/Learning Center (TLC), faculty from the Math and English departments have submitted proposals to increase reassigned time for their directors and for the ESL department to create a director position.

The following proposals will be brought forward to the Palomar Faculty Federation:

20% additional reassigned time for the Math Director, for a total of 60%.

40% new reassigned time for an Assistant Director position, which would provide support for the Math Director in developing the BSI integration effort.

35% additional reassigned time for the English Lab Director, for a total of 60%.

80% reassigned time for the ESL Tutoring Coordinator for one year to establish a tutoring program at the TLC, followed by 60% reassigned time thereafter.

It was noted that the funding for the additional reassigned time would come from the BSI/HSI Grant, but would only last as long as the life of the grant. This leaves unanswered the question of whether the funding of the additional reassigned time might eventually become part of the district's general fund in the event that the State of California withdraws the BSI funds, and the college chooses to continue with the positions.

Discussion followed on the proposals and the duties for faculty members in those positions. Sosa noted that he and Fergal O'Doherty have visited several colleges in the area and have met with several Tutoring Center Directors. All of the centers have either one full-time or two part-time, 50% directors.

Monika Brannick reported that these items will be brought back for action at next week's meeting.

Policies & Procedures:

Brent Gowen stated that Senate members received copies of the Board Policies and Procedures regarding Field Trips and Excursions several weeks ago, and he and Senator Kathleen Sheahan will meet to discuss the proposed changes. Senators will see those brought back for further review in September.

Gowen noted that the Policies & Procedures Task Force met for the last time this semester on Friday, May 8. The group has completed approximately half of its review of Chapter 4. Gowen thanked the faculty members who participated in the review. Meetings will resume in September.

Revised Field Trip Forms:

Senators were provided copies of updated Single-Day Field Trip, Extended Field Trip, and Study Abroad Course Authorization Requests at last week's meeting. Monika Brannick again noted the proposed changes which were recommended by the Senate several months ago that are already reflected in the revised documents. The recommendation to change the approval time from eight weeks to five weeks for the Single-Day International and Extended Day Field Trip Authorization Forms will also likely be implemented.

Motion 12

MSC Laughlin, Gowen: Faculty Senate approval of the Single-Day Field Trip, Extended Field Trip, and Study Abroad Course Authorization Request forms. The motion carried.

Evaluation of Senior Administrators:

For several years Senators have had concerns about the process by which the Faculty Senate traditionally has conducted the faculty's evaluation of Senior Administrators, including confidentially. Over the past several weeks, Senate members have been discussing the Accreditation Team's recommendations that the Senate should no longer orchestrate the process of evaluating administrators. Faculty Senate President Monika Brannick has contacted other colleges in the area and has received some feedback from the Statewide Academic Senate suggesting that such evaluations are usually managed by a different, top-down model.

Brannick stated that the Faculty Senate should consider a change. A new procedure for the Evaluation of Senior Administrators and a new process for their distribution should be created. The role and responsibilities of the district's Personnel Standards & Practices Committee also need to be reviewed and updated to reflect these changes.

Brannick also stated that the Administrator who initially requested a review of the current evaluation process was the Vice President of Student Services, Joe Madrigal. Mr. Madrigal

did file a formal complaint with the district regarding comments included in his evaluation. Brannick and Brent Gowen met with Vice President Madrigal, who has requested that the Faculty Senate compose a letter to him apologizing for what has transpired, noting

especially that the discriminatory comment was kept in his evaluation. He has also requested that the comment be stricken from the document.

Motion 13

MSC Bishop, Levy: The Faculty Senate discontinues its current process for evaluating senior administrators in favor of developing a new policy and procedure. The motion carried.

Lengthy discussion followed on the current process used to evaluate senior administrators. Senators questioned its effectiveness, and others asked how much faculty input and involvement would be sought in a new process. Senators also discussed student evaluations and the process utilized for transcribing those comments, remarking on the limits of censorship, free speech, and the meaning of the Brown Act.

Senators also discussed at length Vice President Madrigal's request that comments be removed from his evaluation. Opinions varied on whether it was appropriate for the Faculty Senate to formally apologize for a comment or comments received from other faculty members and whether it was appropriate or even possible under current practice to remove statements from evaluations, regardless of their nature.

Motion 14

MSC Gowen, Chau: To extend the meeting for seven minutes. The motion carried.

Discussion continued. Some Senators expressed their strong support of Vice President Madrigal and his request for a letter of apology, noting that the college has recently taken a strong stand against hate speech, which opened up that question and created extended debate. Others noted that the previous motion, Motion 13, should be connected to VP Madrigal's concerns, as those concerns, along with the initial report of the Accreditation Team, played a significant part in provoking that action.

Motion 15

MSC Laughlin, Furch: To extend the meeting for five minutes. The motion carried.

The following motion was offered as an amendment to the previously adopted Motion 13:

Motion 13 Amended Motion

MS Kelber, Laughlin: In respectful response to Vice President Madrigal's concerns about derogatory and offensive remarks which were included in the evaluation of senior administrators in 2007/08, the Faculty Senate will discontinue its current process for evaluating senior administrators in favor of developing a new policy and procedure.

The motion was not voted on, pending further discussion and the consideration of other possible responses.

Motion 16

MSC Laughlin, Levy: To table the motion (Motion 13, Amended Motion). The motion carried.
