CALL TO ORDER: The meeting was called to order by the President, Monika Brannick, at 2:00 p.m., in

Room SU-30.

Approval of Minutes:

Motion 1 MSC Morrow, Moore: Faculty Senate approval of the minutes of August 22, 2011, as

amended. The motion carried.

Public Comments: There were no public comments.

Announcements: There were no announcements.

Agenda Changes: Senators agreed to suspend the agenda to discuss Information items C, Palomar College

"No Smoking" Policy, and E, F/FW Grade, due to guests who were present.

Policies & Procedures – Palomar College "No Smoking" Policy:

Monika Brannick indicated that she had spoken with both President Deegan and Vice President Vernoy about Palomar's recent adoption of a "No Smoking" policy. At last week's meeting, Senators discussed challenges with enforcement of the policy, as well as whether enough student input was obtained before the policy was approved by the Governing Board. Brannick noted a memorandum recently distributed by Vice President Vernoy to all faculty, students, and staff outlining the new policy. In the letter, Vernoy asks for help in maintaining a tobacco-free and smoke-free environment here at Palomar College, stating that ..."If you notice someone smoking or using tobacco on campus, please offer a *friendly, brief, gentle, courteous reminder* that Palomar is now smoke-free/tobacco free..." Sherry Titus informed Senators that for the first one to two years the process will be "informational and educational," and, as with all newly adopted policies, there will be a transitional period. She noted that most campuses in the area have also adopted a smoke-free campus and are undergoing a similar transitional period.

Relating to disciplinary action, Titus indicated that no formalized Code of Conduct Violation or Incident Report has been filed due to smoking; not for this policy, nor when the previous policy was in place for smoking only in designated areas, or even prior to that when the policy was "at least 20 feet away from buildings and classrooms." She added that a policy does exist in Ed Code for "willful and persistent smoking," that can

be enforced if it became necessary. Currently, Titus informs students of Palomar's new policy and has received cooperation from students. To date, approximately 4 or 5 calls have been received from the Office of Student Affairs regarding student's use of tobacco.

A question and answer period followed. It was noted that students, faculty, and staff who are smokers are encouraged to go to Health Services where nicotine gum and smoking cessation materials are available.

F/FW Grade:

Susan Snow reported about a recent incident in which she had an email exchange with a staff member of Admissions and Records regarding the final grade of a student. She had given an international student an "F," and the staff member questioned whether that grade should have been an "FW." Snow was eventually informed that international students' grades are sent to Homeland Security, and "W" and "FW" raise issues because students need to be accountable for their time. In this instance, paperwork was filed in error with Homeland Security because the student thought that she/he was receiving a "FW" when instead she/he received an "F." Snow added that when she met with the staff member in Admissions and Records she was informed that she was using the policy improperly as outlined in the Palomar College Catalog. Upon further review of the policy, Herman Lee could find no improper use of the policy by Snow. Because issues have been raised concerning F verses FW, it was suggested that this issue come to the Faculty Senate for further discussion.

Monika Brannick noted that wording in the current policy specifically states that it is up to the discretion of each instructor on how they wish to issue "F" and "FW" grades. Discussion followed on the current policy, particularly how it affects veterans and international students. Some Senators questioned whether the "FW" was even needed, while others expressed the need for it to be used consistently. This issue will be brought back for further discussion at the September 19, 2011, Senate meeting.

Brannick noted that she received clarification from Dean McDonald that the increase in faculty representation is in addition to those faculty members from the Library, Reading, English, Math, Counseling, Professional Development, DRC, and ESL.

Academic Technology Committee:

Lillian Payn stated that members of the Academic Technology Committee met on Thursday, August 25. The group updated the Strategic Plan 2.5, Section G, which states that the committee will complete the Online Training Module to prepare instructors to teach online by the end of Fall, 2011. This will be brought to the Faculty Senate soon.

The committee also established a plan to produce and field test the modules by working in workgroups, which will provide efficiency. September and October will focus on development, November will focus on revising and finalizing, and December will focus on field testing and submission to the Senate.

ASG: No ASG representative was present.

Palomar Faculty Federation:

Perry Snyder reported that the Palomar Faculty Federation will be holding their meetings in two sections this semester: one for dialogue, which will be open to all membership and non-membership faculty, and one for voting, which will be open to membership faculty only.

He added that some of the board members hope to attend a few of the State Council meetings, which they were unable to do last year.

Learning Outcomes Council:

Marty Furch indicated that members of the Learning Outcomes Council met last week for their Orientation meeting. The group heard an update on TracDat, the Palomar Outcomes Database, from Katy French.
