CALL TO ORDER: The meeting was called to order by the president, Monika Brannick, at 2:00 p.m., in

Motion 2 MSC Gowen, Towfiq: To suspend the agenda to discuss Information item F,

Sustainability Education. The motion carried.

Sustainability Education:

Daniel Finkenthal introduced faculty members Sandra Andre, Shannon Lienhart, and Wayne Seward, and provided Senate members with an overview of their participation in a group working to develop programs for education and training to prepare students for sustainable "green jobs." He noted the recent visit to the Senate by Dean Wilma Owens, who provided information on a Clean Energy Workforce Training Program Grant. The group is concerned that this grant, along with others that will likely become available as the interest in green jobs and sustainability grows, will depend on outside contractors for instruction and training. This group urges the Senate to be vigilant in its scrutiny of grant proposals, taking care to primarily support the faculty and staff who are working to design programs to be offered within the Palomar College curriculum by qualified Palomar faculty.

Sandra Andre and Wayne Seward provided additional information on what is driving sustainability practice and why Palomar College should be involved. Andre noted that the US Green Building Council has expressed interest in participating in a pilot program here at Palomar and is willing to send a representative to participate on an advisory committee here as well.

There was overall agreement that faculty participation will be needed in the development of in-house curriculum to support these programs, along with open communication throughout the process of discussing and approving grants.

Monika Brannick asked Daniel Finkenthal to provide periodic reports to the Senate on the progress of the group working towards Palomar's efforts to go green. Senators also suggested that the group contact Cuyamaca College in order to engage as active partners in the early stages of the Clean Energy Workforce Training Program Grant.

Curriculum: Senators were provided with copies of the Curriculum Committee items at last week's

meeting.

Motion 6 MSC Faulkner, Levy: Faculty Senate approval of the Palomar College Curriculum

Committee items dated September 16, 2009. The motion carried.

Monika Brannick reported that she has learned that EME Courses for credit are being taught through Contract Education at the Camp Pendleton campus. This has been occurring since spring of last year. According to Vice President Cuaron, these courses are being taught to the Marines on campus only, and only when there is sufficient enrollment. These classes are not open to the general public. Marine Corps members also receive financial assistance if they qualify.

Brannick added that Vice President Cuaron will call for meetings of the Workforce and Community Development Workgroup to allow for further discussion on this issue.

Policies & Procedures:

Copies of AP 4232, and BP 4232, Pass/No Pass Grading Option, were provided for information. Brent Gowen reported that members of the greater task force have discussed the policy and procedure, and concerns were expressed by President Deegan and ASG Senator Ann Hong with the wording: Students may not repeat a course on a CR/NC P/NP basis a course taken previously taken for a letter grade.

This step in the Policies and Procedures was an attempt to protect students' GPA's; however, President Deegan and Student Government Senator Hong have noted other circumstances in which a student would want to repeat a course on a Pass/No Pass basis, so the task force has asked that the Senate review the Policy and Procedure again in order to make recommendations.

Monika Brannick indicated that she would invite a member of Enrollment Services to an upcoming Senate meeting to answer questions and provide additional information.

Copies of an updated version of the Student Learning Outcomes and Assessment Cycle Plan 2009-14 were provided at last week's meeting. Marty Furch acknowledged the discussion at last week's meeting regarding the plan to "purchase and begin implementation of data-mangement software" as it appeared in the timeline, scheduled for the current semester, Fall 2009. Given the concerns expressed by the Senate, the Learning Outcomes Council has deleted that specific element from the document and now seeks approval of the timeline with that wording removed.

Senate members discussed the proposed changes, acknowledging that the roles and purpose of both committees have changed as a result of PFF representation and the recent accreditation visit.

Senators referred to the proposed paragraph outlining a process which could occur upon request and when Academic Due Process is inappropriate: "...this committee will assist faculty members in resolving differences between or among themselves, especially when these differences involve the faculty members' understanding and interpretation of (1) the Faculty Constitution and/or by-laws, or (2) Governing Board Policies and Administrative Procedures, or (3) departmental by-laws."

MSC Snyder, Sheahan: To extend the meeting. The motion carried.

Senate members discussed potential circumstances where the roles of the Senate and the PFF could be unclear to some faculty members. There was agreement that additional dialogue was needed before voting on this item.
