CALL TO ORDER: The meeting was called to order by the President, Greg Larson, at 2:00 p.m. in Room SU-

30.

Approval of Minutes:

Motion 1 MSC Sinnott, Hernandez: Faculty Senate approval of the minutes of November 16, 2015,

as presented. The motion carried. Abstentions: Glassman, Ritt

Public Comment: There were no public comments.

Announcements: Greg Larson announced that Lawrence Lawson would be on sabbatical next semester and

therefore no longer a member of the Faculty Senate. Senators thanked Lawson for his

service over the last few years.

April Cunningham shared with Senate members that faculty at Saddleback College are receiving compensation related to the implementation of the Canvas Pilot Project utilizing the At-One Training Course. Lillian Payn added that several colleges are offering faculty compensation, or bonuses, for training and implementation of the project and/or when they teach a new DE course. Payn added that Palomar is utilizing Canvas training for the pilot and faculty receive professional development hours. Some faculty do feel that the amount of time it takes to put a robust course online to make it different

than a face-to-face course is not fully recognized or compensated for.

Strategic Planning

Council: The next meeting of the Strategic Planning Council is Tuesday, December 1, 2015.

Governing Board: Greg Larson stated that at the last meeting of the Governing Board, the Board decided in

closed session to close the search for Superintendent/President and open a new search at a later non-specified date. Senate members expressed their disappointment in the board's action, and discussed the need for the Senate to formally respond to the decision.

Members of the hiring committee have also expressed their disappointment in not being contacted prior to it being announced. The lack of consideration for and engagement with the committee and the Palomar community as a whole is disappointing to not only faculty and staff, but to those community members who elected this Governing Board.

This item will be placed on next week's Agenda for further discussion and/or Action.

Palomar Faculty Federation (PFF):

Reporting on the Palomar Faculty Federation and their response to the Governing Board's announcement about the presidential search, Shannon Lienhart noted the significant role the PFF had in getting these Governing Board members elected, and the progress made over the last year or so working together to resolve salary and benefit issues being negotiated by the district and the PFF. She shared the PFF's frustration and disappointment regarding the recent decision to close the search without selecting a candidate, and stated that she will be making a public comment at the Governing Board meeting on December 8, 2016 at 5pm.

After brief discussion, Senate members expressed hope that a large number of faculty and staff will attend the upcoming board meeting.

Student Services Planning Council:

April Cunningham announced that members of the Student Services Planning Council (SSPC) met on November 18. The group discussed SSPC's membership structure and reducing the number of representatives from Counseling and increasing the representation from Enrollment Services. This could reduce the number of faculty members on the council, or bring the membership up to over 20 members.

Instructional Planning Council:

Jackie Martin stated that members of the Instructional Planning Council continue their discussions on Program Review and Planning, with all documents due to Instruction by December 15, 2015.

Academic Technology Committee:

Lillian Payn shared statistics of <u>Internet Class Offering Data</u>, which includes information on the number of students participating in hybrid and online courses beginning in 2011-12 and ending in 2014-15. This provides an opportunity to keep track of any changes or trends of courses that are offered online versus not online. She also shared data on Success/Retention: Duplicated Enrollments. She noted that Non-DE (Duplicated Enrollment) courses have a greater success and retention rate than DE courses. Brief discussion followed.

Basic Skills Committee:

Lawrence Lawson reported that members of the Basic Skills Committee adapted the Student Success and Equity Council (SSEC) Request for Funding form at their last meeting, and adopted that adaptation.

Constitutional Review:

Travis Ritt indicated that a proposal to change the Constitution to reflect a new meeting time of the Faculty Senate from 2:00-3:30 to 2:30-4:00 will be brought forward soon. He asked that Senators review the Constitution in its entirety and forward suggested changes by the end of the semester. It is anticipated that a ballot asking for a vote on proposed Constitutional changes will be distributed to all full-time faculty early in the spring.

Teresa Laughlin added that part-time faculty who serve on hiring committees should receive compensation for their service, which is beyond their contract. Greg Larson indicated that

he would contact Dean Kahn regarding this.
