# It's Official—Site Visit Dates Announced!

It just got real! Congratulations Palomar! We are almost there. We have received word from our accrediting body, ACCJC, that we have been assigned our peer review team chair and our site visit dates. Our peer review team, accompanied by an ACCJC liaison, will be on campus on Monday February 28th through March 3rd and engage in an in-depth review of our Self-Evaluation. They will visit our San Marcos Campus and Education Centers, meet with campus leadership, attend council and committee meetings, and interview campus community members to answer questions they have after a thorough review of our ISER. We should be excited for this visit! We have accomplished so much in the past few years while we continue to provide quality education and support services for our students. Between now and our site visit, will continue to make great strides in growing our campus-wide efforts in diversity, equity, and inclusion, improving our participatory governance, addressing FCMAT recommendations, and so much more! In the spring, we will have a lot to share with our peer review team.

# **ISER Draft for Campus Review**

After two years (has it been that long?) of painstaking, yet rewarding efforts, the writing teams have submitted their final drafts for each of the standards. The collective efforts of the writing teams have resulted in a document that tells Palomar's story. As we continue to refine the draft, the Accreditation Steering Committee is vetting the report against standards and other ACCJC evaluative criteria. While the ISER is still in draft form, we believe it is ready for review by our campus peers and we welcome you to read the entire report, the standards with which you are most familiar, or the standards which most interest you. Whatever feedback you provide will help us put the finishing touches on the document describing who we are, how we shine, and where we see opportunities for growth. This is an important step in the self-evaluation process because it provides an outside perspective on how well Palomar meets the standards. Sometimes it takes a different set of eyes to help us identify our strengths and areas where we could be more clear about how we meet the standards. In the fall, once we have formatted the document, the ISER will presented to the College Council (formerly SPC) and then the Governing Board for approval.
