- 1) Summer Bridge and FYE Gabe
 - i) Chairs ESL, English, Math, Reading: changes to assessment and its impact on SB
 - ii) FAFSA application opened in Oct, using 2015 tax information
 - iii) Students can now apply Spring 17, Summer 17, Fall 17: impact on recruitment for SB?
 - iv) Will take lead from departments
 - (1) Self-reported GPA, prior grades will be included in multiple measures
 - (2) Decision to go against Accuplacer...double the work
 - (3) CELSA not good at placing students into higher levels
 - (4) Common assessment WILL be used, the question is: will it be used in addition to other measures?
 - (5) Multiple measures...in place until common assessment comes on board, then the higher score will be used
 - (6) At the end of SB: post assessment: need to determine process/ tools...to prepare!

 - ii) Spring classes-- pending
 - (1) Reading proposal: READ 110 class
 - (2) Lori: marketing for LC (past present instructors) take the institutional pulse on LC
