### **REQUESTS FOR INFORMATION - QUESTIONS AND RESPONSES**

- (1) QUESTION: Is the proposal to be submitted electronically via email only or is the mailed thumb drive mentioned on pages 4 and 7 also necessary?

*RESPONSE: Please email your submittal as instructed and a thumb drive must be postmarked and mailed as instructed.*

- (2) QUESTION: Are attachments B, C, and D to be included in the submittal?

*RESPONSE: Yes*

- (3) QUESTION: Page 2 mentions the Prevailing Wage Requirements, however, it is our understanding that DSA Inspectors are exempt from the prevailing wage requirements as they are not claimed by any craft. Please see the attached documentation regarding this exemption. Can you clarify this requirement?

*RESPONSE: The Inspector of Record does not fall under SB 854 Prevailing Wage requirements since they are acting in a consulting role on the project.*

- (4) QUESTION: Attachment A on page 9-10 discusses the financial information requested but it references "Architects" multiple times. Also, in our experience, this level of financial information is not the industry standard for DSA inspection qualification packages. Can you clarify what, if any, financial information is required by this RFQ?

*RESPONSE: Any financial information requested is deleted from this RFQ.*
