#### **REQUESTS FOR INFORMATION - QUESTIONS AND RESPONSES**

(1) QUESTION: On the first page of Addendum 3, and on the District's website, it states that the Closing Date/Deadline for Receipt is February 16, 2023 by 3:00 pm. However, in Question 4 on page 2 of Addendum 3 it states, "Responses to this RFQ/P shall now be submitted to the District no later than 3PM on Thursday February 9, 2023." Can you please confirm that the deadline is February 16th at 3pm?

RESPONSE: The last date to submit RFI's is no later than 4pm on February 6, 2023. The District will post responses to RFI's (Addendum) on February 10, 2023. All proposals are due to the District no later than 3:00 PM on February 16, 2023.

(2) QUESTION: In the latest Addendum #3, response to question 4, the district states: "Responses to this RFQ/P shall now be submitted to the District no later than 3PM on Thursday February 9, 2023." However, the schedule in the Addendum says proposals are due February 16th and the last day to submit requests for clarification is February 6th. Could you please clarify the new due dates for both the submittal of requests for clarification, and submittal of proposals?
