Interior Design- Architecture, Other Business/Recommendation

An immense concern brought up amongst the committee members was not having a lab strong enough to sustain the software needs of the programs that are aligned with the current industry standards. The consensus and recommendation of the Advisory Committee members is that the Interior Design and the Architecture programs need better computers that can support the current industry software standards for the students to be able to learn what is current, and obtain the proper skill set while at Palomar College, so that once they graduate are employable within their Industry.

Luisa made a request to collaborate with other departments on campus such as woodshop, and the metal shop as a lot of similar items are done in fabrication shops and it would be a good opportunity for the student to get more hands on experience with the tools.

A suggestions was made regarding the importance of students learning some of the basic measuring skill sets and acquiring a tool kit for the students to lean the essential skills. The Advisory Committee suggested a mandatory kit to be purchased by each student to include a scale, tape measure, angle tractor, laser, and a calculator.

LABS, and LAB TECHS

The Advisory members discussed how the classes were being conducted in conjunction with having proper open lab time for the students. The Advisory Committee members recommended and spoke on the importance of having an open lab for students in both Architecture and Interior Design.

The Advisory also discussions the importance of having a lab tech which would be very helpful in the lab classes. Jessica mentioned she would like to have someone in charge of the materials library and it would be a great opportunity for a student that could lead to a potential job for them. Sherrie mentioned the Design Institute has two people that maintain the resources. Jessica agreed that this would be helpful for Interior Design, and if it was a paid position, it would be something the student could put on their resume.
