1. We are currently reviewing curriculum and offer the AS in Nutrition, but we do not offer any certificates. In terms of making students more competitive for transfer or for employment, are there any specific certifications your organization or you find desirable?

Summary of Committee Comments:

- The experiences and skills acquired that a certificate would represent are what students need to obtain. This seems to be more important than a certificate at graduation with some exceptions. These would cover topics such as:
 - Motivational Interviewing (MI)
 - Some certs i.e. Food Handlers Card or ServSafe Certification would be important for some career paths
- Introducing emerging topics into the curriculum that would not provide expert level knowledge but sufficient exposure to new and developing areas of nutrition are encouraged. Topics include:
 - GI Health and the Microbiome
 - Integrative and Functional Medicine
 - Industry-Specific Qualifications
- The Committee addressed a growing need for community education that would benefit students, current nutrition practitioners, and the community. The Committee recommended offering community education classes where RDs and other nutrition professionals can either expand or update their skillset for direct application in their current workplace with members of the community. This could possibly count as continuing education for the practitioners, and students could be invited to learn advanced topics in NUTR.

2. What, if any, impact on job outlook, employee recruitment, job duties, or any other factors is your organization anticipating with the 2024 changes in degree requirements?

Summary of Committee Comments:

• Overall, the impact of these changes are yet to be seen. While the majority of the Committee agreed that in the years to come there will be fewer well-qualified individuals seeking employment as RDs, the committee also agreed that organizations are emphasizing recruitment, retention, and offering desirable working conditions for RDs. SDSU reported a 100% match rate for interns for the first time. It was also reported that some internship sites had many open spots to fill. Changes in enrollment, applicant, and employment trends are likely to be seen in the next few years. This topic will be revisited next year.
