# A. New Credit Courses

1. Course Number and Title: CHDV 201A Supervised Field Experience in Early Childhood Education

The course is a capstone which allows students to teach classes. The changes to the program with the addition of this course addresses a permit issue for students who need to take it to complete their program. The current course is open to bachelor's degree students as well as existing Palomar students. As such, all of the spaces may be occupied by bachelor's students leaving no space for Palomar students. This newly created course will combine existing courses to accommodate both student groups. This is a short-term solution as the industry changes to allow CHDV to serve more students.

## VII. ACTION - 2018-2019 Curriculum Timeline

## A. New Program Approval Process

#### B. Technical Review

There has been concern that all involved parties aren't closely involved in the review of curriculum. Specific concerns surrounding SLOs, Distance Education and Requisites, among others, need to be addressed. There has been discussion to include a technical review role as a part of the approval process as well as work groups. Origination roles were discussed along with the role of department chairs and/or discipline initiators. This discussion be brought back to the first meeting in September.

#### C. Distance Education (DE) Proposals

Wendy and Gary met to discuss how changes to Title 5 will affect our distance education approval process. Based on the changes, our process will need to be re-evaluated to more adequately address contact, materials and accessibility. Curriculum Committee only evaluates and approved curriculum changes. There is no approval for how the course is actually taught. The college needs to have a discussion regarding these elements as well as determining if our DE courses meet ADA and other guidelines. More work on this will continue over the summer and be brought back in the fall.

## E. Curriqunet META

The new Curriqunet META was demonstrated. Functionality seems to be easier and more user-friendly. There were still some bugs to be worked out but the database was able to be demonstrated with live data. Creating a proposal was demonstrated as well as requirements for each page of the course checklist. Ease-of-use and improved reporting are benefits of this new system. Feedback from the committee was positive. Work will continue over the summer with the goal to go live prior to the fall semester.

# X. **REPORTS**

# A. Academic Technology/Payn

- 1. POET: 43 instructors validated to teach online 2017-18 academic year/ 182 total since Jan. 2012. (FYI: Only 26 last year)
- 2. Faculty Senate requests:
  - a. Best Practices Checklist (Validation of Preparedness to Teach Online) needs to be taken to the next level. (After conducting 3 focus groups, the workgroup is adding a modified set of OEI Rubric Categories to submit to the Faculty Senate
  - b. The College needs to develop a formal DE policy.
     (The DE & AT Committee survey results indicate that the right to set DE policy, select DE faculty and select DE courses should remain at the Department level.)
     (The DE & AT Committee recommends using a template to establish and post Dept. DE policy, so all address the same issues. A sample template was proposed.)
- 3. State Authorization: The faculty at DE & AT Committee and Faculty Senate were polled regarding opinions about out-of-state DE students. Responses indicated that most would like to offer classes to out-of-state students, but realize it is not cost-effective or work-load feasible, but that as time permits, recommend that free-filing states be allowed to enter into an agreement with Palomar, and perhaps also fee-filing States as funds and time permit.

B. **Accreditation/Kahn** – There was no report.

### C. Articulation/Mudgett

Ben recently attended the California Intersegmental Articulation Council Conference. The CSU General Education advisory group will be reviewing traditional foundation courses specifically those less than three units in the arts. However, it would be a good idea to review grandfathered courses heavily focused on life skills approved back in the early 80s to ensure that they meet the current criteria. More information to come next fall. A CSU advisory on how to create a personal finance or computer science course to meet the quantitative reasoning requirement is forthcoming. Lastly, the CSU has heard the intersegmental concerns related to their recommendation not to allow AP units for admission purposes. As such, they have returned to the policy that has always been in place. Also, AP Computer Science Principles will now satisfy Quantitative Reasoning (a new approval) for the CSU.

## D. Basic Skills/Sivert- There was no report.

Planning will happen over the summer to refocus the committee in light of the state's plan to integrate three areas in one block grant for funding. It probably won't happen until next year but Palomar is preparing.

### J. Prerequisite Approvals/Dixon

Ten courses approved. There are seven courses which are not approved (smallest number of courses leftover in approximately two years). Of the seven, four are being actively worked on. Two have had no movement despite numerous communications to include the committee, the chair, dean and VPI. There is acknowledgement but the courses have yet to be completed. The status of the last course is unknown at the moment (it may be being worked on).
