- A. **META** – The glitches identified in META are being addressed and fixed. We are aware of issues involving workflow and multiple users at the same approval step being required to take action. VIII. DISCUSSION

A. Goals – Nelson

Discussion took place regarding establishing goals for this year. Areas discussed included curriculum support/help, noncredit guidelines, the new program approval for, curriculum and the faculty onboarding process, distance education and general education. Goals were reworded and prioritized. The final version resulting from this discussion will be brought back to the next meeting for action.

B. ASSIST-Regional Articulation Council Position on ASSIST – Mudgett

Ben discussed the problems colleges have been having with ASSIST. New platforms have been developed, rolled out and have failed four times citing data integrity issues among other things. The new go-live date in summer of 2019 but there are worries based upon past roll-outs. The Senate took action on a resolution citing these issues and the importance of the system being implemented (correctly). Area D colleges will be taking action on this resolution followed by Region 10 action. Four-year institutions have been providing workarounds but this may not continue for long. A resolution is critical.

C. **Guided Pathways/Mapping Document - Nelson/Kahn**

A draft of the Palomar mapping tool and institutional mapping plans were presented. Workshops for department chairs and discipline representatives have been scheduled throughout the fall semester. Maps will be developed at the workshops and then shared to a Google form (spreadsheet). The workshops will include counselors with a goal of having conversations about maps which may be distributed to students. Mapping can be complicated and counselors don't always give student correct information because they don't have correct information. The goal is to enable students to better plan. Additionally, internship experience, career opportunities, clubs, student activities, etc., should be included in order to offer students a well-rounded educational experience. Program outcomes are an integral part of this process and need to be addressed as well. General Education Outcomes could be a part of a program's outcomes. Suggestions for the form are being requested so that the worksheet may be completed prior to the 1st workshop. The goal is to have all programs mapped by the first curriculum committee meeting of the spring semester. This process can also inform scheduling.

D. **Distance Education Pages in META - Nelson/Perry**

This item was not discussed. The committee was asked to look at the Distance Education handout and be prepared to discuss it at the next meeting.

C. **AB 705/Sivert** – *ENG will offer ENG 100 only with the option of a two unit co-requisite. Students placing lower than 100 can take the co-requisite support course which is tied to the same instructor, in the same room at the same time. Math is looking into something similar. They have decided not to offer anything lower than MATH 54 and looking at the same type of co-requisite model as English. ESL is creating ESL 110 which is an ESL version of ENG 100. Discussion still needs to happen with English but they wanted to get the curriculum proposed. Some of the support courses may be overlap so other options may include noncredit, workshops, online modules or other approaches. When considering ways of implementing AB 705, costs need to be considered. Services such as tutors/embedded tutors increase costs. Many of these programs may be financed with "soft" money. The ability to sustain these services needs to be considered during planning.*
