#### VIII. DISCUSSION

## A. Open Educational Resources-Falcone

Confusion around the use of open resources and how to reflect them on the COR. References and resources will be posted on the curriculum website. CSUs and UCs are on board with OER. Faculty can place OER materials in the "other textbooks/resource" area and leave a traditional textbook as the primary (don't have to use). The traditional textbook can be present for content information. The four year colleges are not in favor of a bunch of links but an actual book. Publisher (representative) textbooks should remain. If choosing to use a low cost option, it can be listed. OERs also don't have to be listed at all. CSUs/UCs and California Community Colleges are all working toward low-cost textbook options. Although the four year institutions may not know what the OER is, they will be able to identify the primary textbook. *Openstax* is the most widely accepted as they have gone through a similar vetting process as traditional textbooks. We now have a direct connection there. Some books are also distributed through Creative Commons as pdfs. As long as pdf book is legally distributed, it is okay to use. There are grants available to encourage the transition of course materials/ Textbooks are often big barriers for students especially when working with high-school students in transition programs. Palomar is making significant progress. We will be able to make even more progress with the mapping initiative.

## C. High School Articulation (CTE Transitions) Credit by Exam Policy - Sebring

The current CTE Transitions policy is not beneficial to our students. High School teachers put grades into CATEMA only if college credit is requested but grading only includes Pass/No Pass. Pass is a "B" or better. This could be a problem at the 4 year as "Pass" is not often accepted. Suzanne suggested adopting a final exam (credit-by-exam) policy where the student would get a grade and the grade would be reflected. Another problem is that a, student can't retake a course to get a grade as they have already received a passing mark. Current articulation agreements would have to be reviewed as a part of this process. Grading would be done by high school teachers since we already have these agreements in place. Courses with portfolios would be handled similarly after having conversations with high school faculty counterparts to determine what is passing and what is not. Proctoring on the college campus is also an option. The exam would become a part of the articulated courses. Currently, the student has to apply for credit. This policy would apply to high

schools only, not adult schools. Feedback from the Curriculum Committee and Faculty Senate is necessary. This would then go to Policies and Procedures. It could potentially live in the Credit by Exam policy since it is there as well as in Articulation. A process will be developed and finalized, then sent to Curriculum and Faculty Senate for a vote.

## D. Distance Education Pages in META - Nelson/Perry

Changes are being considered in order to improve the distance education process and to meet Title 5 requirements. Accessibility needs to be addressed for the future. The goal is to provide a few more meaningful and thoughtful questions to get better responses. Committee members were asked to read through the document and offer suggestions. The page will educate users as well as ask questions. Regular and effective communication and contact questions are more clearly defined to align with Title 5. The questions also address instructor education/preparation to teach online. Nothing has been decided in the instructor preparation area, but we should begin to address this ahead of any policy decisions. The language in the accessibility are has been adjusted to address all students, not just the disabled ones. We need to be proactive for all students. It was suggested to leave some language about disabilities since some instructors don't know that accessibility can affect disabled students. It was also suggested that perhaps "security" should be replaced with "academic integrity" or "honesty." Resources for students to assess their readiness to take an online class should be readily available. The committee's discussion brought questions about whether separate approval in order to teach online courses needs to happen. It seems we may be already doing this so it may not be necessary. These changes will be brought back for action once finalized.

### E. New Program Form

New program, Law, Public Policy and Society was discussed at IPC. IPC hasn't decided on a process to vet new programs but didn't want to hold the program up. Members of IPC asked really critical questions regarding units, the ability of students to finish, the need for new courses and SLOs. This program uses existing courses so there are no new costs incurred. The department was prepared to discuss the program and all relevant areas so they were well prepared. A checklist was recommended for people to consider when evaluating a program. Questions which are useful when evaluating were noted. Problems should be handled by departments prior to IPC. This process is a work in progress.

#### F. Guided Pathways/Mapping Document - Nelson/Kahn

The edited map looks very different but still contain same information. Suggestions such as description, program outcomes (with a link to Tracdat), Careers (ONET) and skills were incorporated. A student resource section (clubs, activities, scholarships, internships) was added. A place for transfer notes was added. Semesters include fall and spring only. Suggestion may be made in the acceleration section to assist students with finishing faster. Maps can be emailed or loaded to websites. Members were asked to share this information with constituent groups because mapping that is not done will not be made public.
