The Associate Dean position oversees Palomar's extensive Apprenticeship program (biggest in the area) which is a credit program as well as noncredit courses. Palomar has a different setup whereas other colleges would have two separate areas. The ratio of faculty to administrators would essentially remain the same. The Faculty Senate acknowledged the need for voting rights for this Associate Dean position

only, not any others (future). They also recommended that the Director of Occupational and Noncredit programs would not need a vote because those interests are covered by the Dean's vote.

XI. **DISCUSSION**

A. **2017-2018 Curriculum Goals**

Discussion to establish this year's goals continued. The Computer Proficiency/Information Competency was removed due to an inability to define what the goal means and how it may be accomplished. There are other initiatives being developed or already developed to prepare students for online learning. The committee agreed with what is already available. Lillian offered to forward the link to a resource which is available to assist students.

The decision was made to rewrite the goal surrounding General Education (GE). The list of GE courses that Palomar offers is extremely large and can be overwhelming to students (confirmed by the ASG student representative). Many are mostly local GE while a small percentage of the overall number actually transfer to a 4-year as GE. Questions included whether the lists need to be reorganized or streamlined and what role does the Curriculum Committee play in this conversation? There were also questions around General Studies degrees and how they will be affected by the Guided Pathways initiative happening around the state. Some wonder if our current GE courses will fit into Guided Pathways. The discussion asked committee members to consider what Palomar's GE courses say about the institution. Some think these courses may dilute other courses. The college needs to work together to develop a philosophy about its GE. It was recommended that conversations around the breadth or GE and outcomes for GE areas be discussed in meetings and forums for one year in order to inform a plan. Faculty and representatives from the CSU and UC should be a part of this.

For Distance Education, discussion included how to delineate the line between Academic Technology and Distance Education. Title 5 requires Palomar to make sure language and procedures are in place in order to ensure accessibility and that online courses are as rigorous and meaningful as face-to-face courses. Discussion included field trips and orientations for online classes. Expectations and accommodations need to be made clear for student information. There was also discussion about how online courses can affect transfer especially for STEM majors. The committee acknowledged that the review process can be strengthened to be more meaningful.

The University Studies goal was accomplished and so was removed from the list. The "deadlines" goal was moved to 'ongoing,' the requisite goal was discussed in order to be rewritten and the noncredit goal was moved to 'ongoing.' Goals for the Guided Pathways Initiative and the Annual Credit Course Certification were added.

- POET update: 10 new certificates this fall semester so far, making a total of 150 instructors validated to teach online since January, 2012.
ATRC statistics as of Sept 30: Blackboard Courses Available: 749; Canvas Courses Published: 724; Teachers using Canvas: 384; Students using Canvas: 14,137
The Committee has new members and returning members with a vigorous mix of interests, talents and enthusiasm. They have set committee goals for the year, and have already been discussing campus requests, such as from TERB.
