# IX. **DISCUSSION**

#### A. Deactivation of Courses

The communication to be distributed to identify courses recommended for deactivation was discussed.

#### **B.** Guided Pathways

VPI Kahn again stated that the assessment report will be distributed. He stated that he would share it with the Curriculum Committee. He further discussed Guided Pathways and stated that it was an effort to assess student needs and, in even some cases, connect with middle and high schools to prepare students for college matriculation. Areas to be developed include Meta majors, streamlining college and student language so that more clear communication happens. Colleges need to be more organized from a student perspective and there needs to be more support built in including counseling and internships. Even providing more streamlined degrees such as ADTs doesn't offer a clear path for students to complete studies as there may still be conflicts such as when classes are scheduled and when students can take them. Students may be confused or overwhelmed by too many options and this initiative is being developed to remove some of those obstacles. Infrastructure changes, such as Starfish and Early Alert, are also being developed.

## C. District Curriculum Planning

No process exists by which curriculum development is evaluated. There is nothing which would prevent anyone from spending a lot of time developing curriculum that is not approved or able to be supported by the college. Discussion took place about a process which could potentially include curriculum development vetted by the department chair, faculty, dean and Articulation Officer. This would also address overlap as the overlap field in Curricunet may no longer be effective. Any process developed should not be so regimented as to stifle faculty innovation. Suggestions for checklists or utilizing a similar process to the one for deactivating a program were discussed as well as sharing this information more institutionally, for instance with the Instructional Planning Council. Sharing the information would allow the college to potentially develop complementary programs and respond to workforce/major needs. Code alignment to ensure accurate apportionment should occur. Development of a process will continue to be explored.

# D. Curriculum Approval Process and Tech Meetings

Wendy presented models of curriculum review processes from other colleges. Some have a dedicated technical writer. Smaller groups meet outside the committee meeting to thoroughly review curriculum

including requisites, grammar, coding and other aspects. The curriculum then goes for first reading and If okay, goes to second reading and approval. Meeting on off weeks for this type of review was discussed.

E. Accelerated Course Approval/Effective Dates – This item was tabled for a future meeting.

## F. Noncredit Numbering

Cheryl Kearse explained that the noncredit re-numbering handout displays existing noncredit courses not numbered in the 900s. The committee voted that noncredit curriculum be numbered in the 900s. This removes the confusion that some 4-year institutions have regarding Palomar's numbering classification (some have questioned why some noncredit courses are numbered as upper division courses). The courses on the handout represent older noncredit courses with proposed number changes. The committee was asked to review the document and bring back any feedback. There have already been concerns brought by the ESL (English as a Second Language) department which will be addressed.

Attendees will receive a "Quick Start Guide".

ATRC has started an Accessible Course Delivery Pilot at the request of the ADA Compliance Workgroup chaired by VPI Kahn. We have 12 participants so far and have room for more if anyone would like to still volunteer. Our convenience sample includes almost all women instructors, so it would be interesting to see if male instructors have different feedback regarding accessibility. Participants will get assistance from our instructional designer as well as students who use assistive devices, software and hardware in order to ensure ADA compliance. We plan to learn the most efficient procedures to deliver ADA compliant courses.

The Distance Education and Academic Technology Committee suggested revisions to Palomar College's AP 4105. We referred to Title 5, ACCJC Standards, as well as the AP 4105 at other colleges. While we didn't change a lot, we did make very worthwhile recommendations in the document that we returned to the Senate Committee on Policy and Procedures.
