Federal law requires all males, between the ages of 18 & 25, register with the Selective Service System. Your status with the Selective Service is checked prior to determining financial aid eligibility. If registration with the Selective Service cannot be confirmed, you must submit proof of registration or, if exempt from registering, you must submit documentation of your exempt status.

Attach ONE of the following documents to this form: (1) PHOTOCOPY of your Selective Service Registration Card OR (2) PHOTOCOPY of your Selective Service Registration acknowledgment (available after registration with Selective Service at www.sss.gov).
<input type="checkbox"/>	I am a Veteran. Attach a PHOTOCOPY of your DD214
<input type="checkbox"/>	I am currently in the armed services & on active duty (this exception does not apply to members of the reserve & National Guard who are not on active duty). Attach a PHOTOCOPY of current LES statement.
<input type="checkbox"/>	I entered the US after the age of 26 years old & have not registered for Selective Service. Attach PHOTOCOPIES OF PROOF OF DATE OF BIRTH & ONE of the following documents: (1) Proof of immigration date to the US from an entry stamp on the I-94 form or on the passport, OR (2) Letter from the US Citizenship & Immigration Services (USCIS) indicating the date you entered the US &, for those in the US on a valid visa who are at least 18 & less than 26 years old, a student visa form (I-20) or other valid US passport visa stamp with expiration date (the dates must be from entry until after you turned 26).
<input type="checkbox"/>	I am over 26 years old & have not registered for Selective Service. You must attach a PHOTOCOPY of the Status Information Letter obtained from www.sss.gov AND a written statement explaining your failure to register for Selective Service. Please make sure you address the following in your written statement: (1) where you lived when you were 18 through 25 years of age, (2) whether you thought you were registered, if so, why & attach any supporting documentation AND (3) if you were not aware you were required to register, why & how you were not aware of the widely publicized requirement to register for Selective Service.
<input type="checkbox"/>	I entered the US on a valid nonimmigrant Visa & remained under the same status until my 26th birthday. You must attach documentation that indicates you were admitted on a F-1 visa & attended school full time as required. Acceptable documentation includes a PHOTOCOPY of Form I-20 or a letter from the school you attended indicating full time attendance as a nonimmigrant alien. The same applies for all nonimmigrant statuses.
<input type="checkbox"/>	I have not registered with Selective Service because I am exempt for one of the following reasons: (1) I was assigned the gender female at birth, (2) I have not reached my 18th birthday or (3) I was born before 1960.
