Purpose: This form is intended for students who wish to request a reconsideration of a financial aid decision based on extenuating circumstances or additional information that was not previously considered. Whether your first appeal for Satisfactory Academic Progress (SAP) was denied, you have already obtained a bachelor's degree and want to be considered for student loans, or you have any other circumstance that may require a secondary review, the form will provide you with the necessary steps.

Important:

- If your appeal is approved, your eligibility is reinstated as of the current semester and is not retroactive to prior semesters.
- The decision of the Appeal to the Financial Aid Director is FINAL. No further appeals will be considered.

Fall 2023 – December 15, 2023 Spring 2024 – May 17, 2024 Summer 2024 – August 9, 2024
