- CALL TO ORDER:** The meeting was called to order by the President, Greg Larson, at 2:00 p.m. in Room SU-30.
- Approval of Minutes:**
- Motion 1** MSC Laughlin, Fererro: Faculty Senate approval of the minutes of October 14, 2013, as amended. The motion carried.
- Public Comments:** There were no public comments.
- Announcements:** Lillian Payn announced that Graphic Communications will host an Open House on Thursday, October 24, from 5:00 – 8:00 p.m. in the MD building, first floor. Several exhibits as well as a gallery of student works will be featured.
- Patrick O'Brien announced that the college will be hosting a College Fair Day on Tuesday, October 22. Several colleges will be present to provide information to students.
- Agenda Changes:** Senators agreed to suspend the agenda to discuss Information Items A & E, Student Success Task Force (SSTF) Recommendations, and Academic Calendar, due to guests being present.
- SSTF Recommendations:** Adrian Gonzales, Vice President of Student Services, shared a slideshow on the Student Success & Support Program. He provided data on the historical context behind the program, which is the creation of a 20 member task force by the California Community College Board of Governors to develop a strategic plan for improving student success. The Task Force developed 8 recommendations and a review of outcomes based funding. Within the 8 recommendations, there are 22 specific policy changes, and the following recommendations now have legislation in place to support them:
- Recommendation 2: Strengthen Support for Incoming Students (assessment, orientation, SEPs, required participation in support services, better use of technology). This policy requires students to participate in diagnostic assessment, orientation and the development of an educational plan (SB 1456).

- Recommendation 3: Incentivize Student Behaviors (enrollment priorities, conditions for receiving a BOG Waiver.) This policy requires Palomar to adopt system-wide enrollment priorities reflecting the core mission of community colleges (Title 5) and to ensure that students receiving a BOG Fee Waiver meet various conditions and requirements.
- Recommendation 8: Align Resources with Student Success Recommendations. This policy requires Palomar to invest in the new Student Support Initiative (SB 1456).

Next steps for Palomar:

- Review Student Education Plan (SEP) development
- Discuss the role of instructional faculty in advising services
- Refine current priority enrollment process to align with Title 5 changes
- Implement changes in PeopleSoft to address process changes and MIS data collection needs.

A lengthy question and answer period followed. Some Senate members expressed concern with outcomes-based funding and urged the administration to speak on behalf of faculty and students about the importance of authentic student success. Gonzalez and Cuaron agreed. They indicated the need for faculty participation and oversight throughout the process of responding to these changes and suggested the creation of a Steering Committee to provide oversight and a process for open communication.

Academic Calendar:

The Academic Calendar Workgroup was convened in Spring 2013 to develop recommendation(s) for an academic calendar that is compliant with all Title 5 requirements and to provide guidelines for the development of current and future calendars. The workgroup met on May 8, September 19, and September 26, 2013, and used the following guiding principles in developing its recommendation(s):

Guiding Principles

1. Develop academic calendar options that:

- a. Comply with Title 5 regulations §55700 §58142, 175-day traditional calendar
- b. Comply with State of California Mandated holiday dates (Ed Code 79020)
- c. Ensure 16 class meeting days for primary teaching days of Monday – Friday for both Fall and Spring semesters to facilitate scheduling classes at least the minimum lecture or lab face-to-face contact hours required per one credit hour (Title 5 §55002.5)
- d. Support existing class scheduling blocks as much as possible
- e. Protect 12 professional development days

- f. Consider calendar trends of surrounding K-12 and community college districts
- 2. Recommendations for future planning:
 - a. When Veteran's Day Holiday must be observed on Monday –
 - i. the instructional day (Monday) may be made up on the Monday of Thanksgiving week, or
 - ii. the term can be extended to capture the trailing Monday (using 3 non-instructional days in the Fall term of adjust the PD days)
 - b. Research the option to move to a 32-week Compressed Calendar.

Berta Cuaron and Kendyl Magnuson distributed copies of two options for the 2014-15 academic calendar, and discussion occurred on the proposals.

Greg Larson noted that the membership of the Calendar Committee includes three faculty appointed by the PFF but none appointed by the Faculty Senate, stating that this is an academic matter as well as a working conditions issue. Teresa Laughlin indicated that the membership structure is included in the contract, though the issue can be brought before the eBoard for consideration.

Election Process:

Patrick O'Brien reminded Senate members of discussion held several weeks ago and the change made to the Faculty Senate voting process, which now states that a candidate needs a majority vote to be appointed to a committee. There was an issue raised on how multiple appointments for service on the same committee would be made and if a change to the current process would be proposed. O'Brien indicated that there is no precedence in place with the Statewide Academic Senate because in those instances the President makes the appointment. The Senate will retain its current process for multiple appointments with the highest vote-getters being appointed.
