CALL TO ORDER: The meeting was called to order by the President, Greg Larson, at 2:00 p.m. in Room SU-30.

Strategic Planning Council:

Greg Larson distributed copies of a document on Actionable Improvement Plans which are being brought as a result of the Accreditation Report. He referred to items referencing diversity and hiring and effective shared governance, which fall under the purview of the Senate. This item will be placed on the Agenda for discussion at next week's meeting.

Governing Board:

Greg Larson stated that the timeline for hiring of the next Superintendent/President was discussed at the recent Governing Board meeting on October 28. The timeline initially proposed by President Deegan was not entertained for action by the board but there was approval of an amended Search Committee structure. The Search Committee will set the timeline for hiring and choose a consultant for hire. It will be a 26-member group; 12 of which will be faculty members. Discussion followed on the timeline and how the selection process of approving faculty will occur.

Shannon Lienhart reported that she is working with Kendyl Magnuson on the Policy Procedures referring to Free Speech and they will be brought to the Senate for information soon.

She stated that the campus visit from Tom Torlakson, Candidate for California State Superintendent of Public Instruction on Tuesday, October 28 was a success, with a very large crowd of approximately 200 people.

Lienhart also provided an update on the ACCJC trial currently ongoing related to the accreditation of City College of San Francisco.

VII. RESUMPTION OF REGULAR AGENDA

A. **Action** – Curriculum proposals stuck at any step of the Curricunet approval process for 2 or more years will be removed after notification to the proposal originator.

VIII. ACTION - TECHNICAL CORRECTIONS

A. **BIOL 118 (General Ecology-Lecture) and BIOL 118L (General Ecology-Laboratory)** were approved as **Credit Course Deactivations** on the September 17, 2014 Curriculum Committee agenda. The department has decided to retain both courses. These courses will not be deactivated.

B. New course, **ACS 180**, was approved for **2 units, 6 - 9.5 hours per week of laboratory hours**. Based upon feedback from the Chancellor's Office, the course is being changed to **2 units, 6 hours per week of laboratory hours**.

C. **KINE 117C** was approved with a T.O.P. Code of **1270.00-Kinesiology**. Based upon feedback from the Chancellor's Office, the T.O.P. Code is being changed to **0835.00-Physical Education**.

D. **KINE 140B and KINE 155B** were approved as .5, 1 or 1.5 lecture hours and 1.5, 2 or 3 laboratory hours for 1, 1.5 or 2 variable units. Based upon Chancellor's Office feedback, the variable unit values are now **1, 1.5, 2 or 2.5**.

E. **MUS 178 and MUS 179** were approved at the May 7, 2014 Curriculum Committee meeting effective Fall 2014. The courses should have been approved with an effective date of **Fall 2015**.

PRP for 2014-15: Copies of the Palomar College Academic Programs – Program Review and Planning (PRP) for 2014-15 were distributed. Jackie Martin provided an overview of the changes made to the document, which is now in a narrative format. Discussion followed and Senate members made some minor recommendations for amendments.

Motion 2 MSC Albistegui-Dubois, Furch: Faculty Senate approval of the Program Review and Planning Update – Academic Year 2014-15, as amended. The motion carried.

Hiring Procedures –
Administrative
Positions:

As discussed earlier in the meeting, the Faculty Senate plays a large role in the appointment of faculty to the Presidential Search Committee. Senate members discussed how the appointment of 7 full-time and 2 part-time faculty who will serve on that committee will occur. There was agreement that divisional representation as well as one Senator should be appointed for the full-time positions, and that the part-timers appointed should be those who have been employed at the district for some time. Senate members also agreed that faculty members who plan to retire with the Supplemental Early Retirement Plan (SERP) should exclude themselves from the process. This item will be brought back for Faculty Senate Action at next week's meeting.

Policies & Procedures:

Greg Larson shared BP 5500 Standards of Student Contact, on the overhead. He and Jenny Fererro noted the changes made to the document based on the Senate's recommendations. This will be forwarded on to the Policies & Procedures Committee.

Senate members were provided with copies of AP 3430, Prohibition of Harassment, and BP 3410, Nondiscrimination.

Monika Brannick provided information on the previous edits made to these policies and procedures and how changes are being proposed to bring the document clarity and provide clearer definitions of bullying and harassment.

Lengthy discussion followed on the documents, and opinions varied on whether there was an advantage to having the additional language on bullying added to the documents as all possible scenarios could never be outlined. For example, there are specific notations of bullying but the outline on harassment is not as clear. Some Senate members felt that some incidences were up to interpretation and could potentially violate free speech. Brannick reiterated that it was noted that the document stresses a pattern of behavior that is repeated over time, and that the added wording provides additional clarity. There are potential issues related to the contract as any wording leading to faculty discipline needs to be a PFF issue.

This item will be brought back for further discussion next week.
