3. Guide to Identifying Repeatable Courses

Guide to Identifying Repeatable Courses

This document is intended to provide guidance to faculty, deans, the Curriculum Committee, and Faculty Senate for determining whether courses should be repeatable and for selecting the proper Title 5 justification.

Below are the four reasons that a course can be approved as repeatable. For the purposes of this guide, they are labeled Option A, Option B, Option C, and Option D.

Option A: T5 Section 55041(c)(2)(B)(i) The course is an activity course where the student meets course objectives by repeating a similar primary educational activity and the student gains an expanded educational experience each time the course is repeated because **skills or proficiencies are enhanced by supervised repetition and practice within class periods.**

This justification would typically be selected for an activity course where supervised repetition and practice in class provides an opportunity for the student to improve skills and knowledge. Examples are: Software courses, physical education courses, visual or performing arts in music, theatre or dance.

Option B: T5 Section 55041(c)(2)(B)(ii) The course is an activity course where the student meets course objectives by repeating a similar primary educational activity and the student gains an expanded educational experience each time the course is repeated because **active participatory experience in individual study or group assignments is the basic means by which learning objectives are obtained.**

This justification might be selected for an activity course such as field studies or performance studies courses where some independent work might be required along with supervised study.

Option C: T5 Section 55041(c)(2)(A) The **course content differs** significantly each time it is offered.

This justification would typically be selected for a topics course or other similar course such as directed study where the course content differs significantly each time it is offered.

Option D: T5 Section 55041(b) The course is required for **legally mandated training.**

This option may only be used if course repetition is required by statute or regulation. An example would be a federal or state statute or regulation requiring certain individuals to complete a specified number of hours of education in order to maintain their certification, licensure or ability to work in particular fields, such as in the public safety and health care fields.

Group Repeatability of Courses in the Same Primary Activity

Repetition is limited to a total of four completions in activity courses when two or more courses in the same activity either (1) offer varying levels of that activity or (2) offer variations of the activity.

Examples:

- Beginning Aerobics, Intermediate Aerobics, and Advanced Aerobics Students would be allowed to repeat these activity courses; however, the repetition would be limited to a maximum of four completions of a single course or any combination of the three courses.
- Masters Swimming, Distance Swimming, and Swimming for the Triathlete Students would be allowed to repeat these activity courses; however, the repetition would be limited to four completions of a single course or any combination of the three courses. Where Palomar has identified courses that are of similar activity for repeat purposes, a note such as the sample below is included in the college catalog to alert students of repeat limitations.

Kathleen Sheahan provided copies of the following summary of Fall 2008 student demographics:

Demographics of Fall'08 Credit Students Segmented by Whether They:

- (1) Took all of their course(s) on the Internet that term -- i.e. "**Internet Only**";
- (2) Took Internet course(s) plus course(s) taught in other instructional modes -- i.e. "**Both**";
- (3) Exclusively took course(s) in other instructional modes -- i.e. "**Non Internet Only**".

Page#1 **Overview**

- Of the 24,828 students who qualified for inclusion in the study:
 - 1,167 (4.7% ... 1 of every 20) took Internet courses ONLY that term;
 - 2,496 (10.1% ... 2 of every 20) took BOTH Internet AND Non-Internet courses;
 - 21,165 (85.2% ... 17 of every 20) took Non-Internet courses ONLY.
- Internet Only students exhibited the lowest success rate (59.4%) and retention rate (88.3%).

- Success rate was almost 10 percentage points higher (69.2% vs 59.4%) for the students who took Both iNet & Non iNet.
- Likewise, those who took courses of both types were 4 percentage points higher in retention rate (92.4% vs 88.3%).
- Those who took Non Internet courses Only had the highest success (70.5%) and retention (94.6%) rates.

Focusing now on only those students who took BOTH Internet AND Non Internet courses...

- Success rate in their Non iNet courses was 12 percentage points higher than in iNet courses (73.4% vs 61.3%).
- Likewise, Non iNet retention was 5 percentage points higher than iNet (94.1% vs 89.1%).

Page#2 **Full-Time versus Part-Time Status**

- Students are broken out by unit load (12+ units = Full Time, <12 units = Part Time).
- Strikingly few (3.3%) of iNet Only students carried a full time unit load.
- Strikingly many (54.5%) of those who took courses of both types carried a full time unit load. (Oh that we had more students who took such loads.)
- 28.8% of the traditional Non Internet Only students carried a full time load (that is the "normal" % for the student body).
- Within the Full Time student group, the pattern of success & retention rates is the same as we saw earlier:
lowest for iNet Only, highest for Non iNet Only and "in between" for those who took courses of both types.
- Within the Part Time student group, that same pattern holds.

Focusing again on only those students who took BOTH Internet AND Non Internet courses...

- Among Full Time students:
 - Success rate was 12 percentage points higher in their Non iNet courses (74.9% vs 63.1%);
 - Retention rate was 4 percentage points higher in their Non iNet courses (94.4% vs 90.7%).
- Among Part Time students:
 - Success rate was 11 percentage points higher in their Non iNet courses (69.5% vs 58.8%);
 - Retention rate was 6 percentage points higher in their Non iNet courses (93.3% vs 86.9%).

Page#3 **Average Unit & Enrollment Loads**

- We take a closer look at unit loads and enrollment loads among Full Time & Part Time students.
 - Average Unit load for Full Time iNet Only students (12.5 units) falls 1.5 units below the other two groups (14.0-14.1).
 - Average Enrollment load for Full Time iNet Only students (4.3 courses) is lower, but close to the other groups (4.5-4.6).
 - Average Unit load for Part Time iNet Only students (3.9 units) was:
 - less than half of the average unit load for those who took courses of both types (8.0);
 - 1.7 units less than for those who took Non Internet Only (5.6).
 - It is interesting to note that part timer's who took courses of both types had average unit load 2.4 higher than Non iNet Only. (Oh that the part time Non iNet Only students had average unit loads that high.)
 - Average Enrolment load for Part Time iNet Only students (1.4 courses) was:
 - half of the average enrollment load for those who took courses of both types (2.8);
 - 0.4 courses less than for those who took Non Internet Only (1.8).
- Focusing again on only those students who took BOTH Internet AND Non Internet courses...
- Among Full Time students:
 - 28% of their total average Unit load (4.0 of 14.1) was allocated to iNet courses;
 - 30% of their total average Enrollment load (1.4 of 4.6) was allocated to iNet courses.
 - Among Part Time students:
 - 41% of their total average Unit load (3.3 of 8.0) was allocated to iNet courses;
 - 43% of their total average Enrollment load (1.2 of 2.8) was allocated to iNet courses.

Page#4 **Age & Gender**

- Those in the iNet Only group tend to be older. Half were 27 or older while half the other groups were 21 or younger.
- Those in the iNet Only group were the most likely to be female (61.6%).
- The female percentage drops by 6 points to 55.4% among those who took courses of both types.
- The traditional Non Internet Only students were only 48.5% female (much closer to "normal" for the student body).

Page#5 **Ethnicity**

- Whites were over represented in the iNet Only (59.6%) and BOTH (58.1%) groups versus Non iNet Only (49.7%).
- Hispanics were under represented in the iNet Only (17.7%) and BOTH (18.6%) groups versus Non iNet Only (27.6%).

- However, 1st-Time Transfer students make up 17.0% of iNet Only's. (Perhaps co-enrolled at another CCC or 4-Yr?)

Page#6 **Education Goal**

- iNet Only students were the LEAST likely to have a transfer goal (36.2%).
- Those who took courses of Both types were the MOST likely to have a transfer goal (54.5%).
- Traditional Non iNet Only students fell somewhere in between (45.2%) with respect to having a transfer goal.

Page#7 **Community College District of Residence**

- iNet Only students were the LEAST likely to reside within Palomar College District boundaries (63.8%) versus Non iNet Only's (73.4%) and those who took courses of both types (also 73.4%).

Page#7 **In-District Community of Residence**

- Students who reside in San Marcos are under represented in the iNet Only group (9.6%) versus those who took courses of both types (12.6%) and the traditional Non iNet Only group (14.1%).

- iNet Only students were by far the LEAST likely to "persist" to Spring'09 (62.4% took no Spring classes).
- Those who took BOTH types were the MOST likely to persist to Spring'09 (only 26.4% took no Spring classes).

- Traditional Non iNet Only students fell somewhere in between (36.2% took no Spring classes).
 - The Fall'08 success rate for iNet Only students who DID NOT return in Spring (52.3%) was lower than that for any of the iNet Only group members who DID return in Spring (67.8%, 77.9%, 66.2%). That same success rate pattern holds for the Non Internet Only group and the BOTH group members who DID NOT return in Spring.
 - Of the 439 iNet Only students who returned in Spring: 43.7% stayed iNet Only for their Spring course work, 21.6% switched to BOTH and 34.6% switched to Non Internet Only.
 - Of the 1,836 BOTH students who returned in Spring: 39.3% stayed BOTH for their Spring course work, 7.1% switched to iNet Only and 53.6% switched to Non Internet Only.
 - Of the 13,509 Non iNet Only students who returned in Spring: 88.1% stayed Non iNet Only for their Spring course work, 1.7% switched to iNet Only and 10.2% switched to BOTH.
- Focusing now on only those Fall'08 students who took BOTH Internet AND Non Internet courses...
- The Fall'08 iNet success rate for BOTH students who DID NOT return in Spring (44.5%) was lower than that for any of the BOTH group members who DID return in Spring (68.4%, 75.1%, 61.0%).
 - The Fall'08 Non iNet success rate for BOTH students who DID NOT return in Spring (56.4%) was lower than that for any of the BOTH group members who DID return in Spring (73.9%, 80.3%, 76.8%).
- Page #9 Fall'08 Grade Distributions: "Active" (W) & "Passive" (FW) Withdrawals**
- We take a closer look at Fall'08 grade distributions for the three groups.
 - The groups differed in terms of the proportion of "active" withdrawal (W) plus "passive" withdrawal (FW) grades received.
 - At 22.4%, iNet Only students had the Highest proportion of withdrawals (10.7% FW's plus 11.7% W's).
 - At 12.2%, traditional Non iNet Only's had the Lowest proportion of withdrawals (6.8% FW's plus 5.4% W's).
 - Those who took Both types fell somewhere in between at 14.7% (7.1% FW's plus 7.6% W's).
- Focusing again on only those students who took BOTH Internet AND Non Internet courses...
- Those who took BOTH had a higher proportion of withdrawals in their iNet courses (19.8% versus 12.1% for Non iNet).
 - the 19.8% iNet withdrawals breaks down 8.9% FW's plus 10.9% W's;
 - the 12.1% for Non iNet work breaks down 6.2% FW's plus 5.9% W's.

Sheahan reported that the document was the result of work completed by one of the six workgroups recently formed by the committee. She provided an overview of the document and a brief question and answer period followed.

Policies &
Procedures:

Brent Gowen indicated that BP/AP 4235, Credit by Examination, has been reviewed by Herman Lee and members of Enrollment Services, and several changes were being recommended.

The document will be reviewed by Chairs and Directors to assure that it is current. It will be brought back to the Faculty Senate in the spring semester.

Review/Revision of
Forms:

Over the past several weeks, Senate members have been discussing the Application for Audit form and whether, given the current environment, accommodations should be made in any case, as the district is currently not soliciting enrollment. Approvals for audits and overlapping classes should be given with much discretion and only in rare cases. At last week's meeting, there was discussion regarding whether it was appropriate to request that members of the faculty temporarily eliminate the student permission of class audits and enrollment into overlapping classes. It was pointed out, though, that the "audit" option is often essential for students involved in performance activities.

There was additional discussion regarding possible responses to budget cuts, including the possibility of implementing the following:

- Limit or eliminate online crashers
- Date of drop for nonpayment should be moved up by administration
- Limit the number of units in which students can enroll
- Enforce prerequisite requirements
- Last day to drop should be moved up by administration
- Limit or eliminate registration by younger (high school age) students

Senators discussed bringing this item back in the spring semester for further discussion and a possible resolution from the Faculty Senate. One Senator suggested that the language of any potential resolution would have to acknowledge the need for exceptions, as all classes are unique, and any regulation would have to allow for the discretion of departments and/or individual instructors.

Learning Outcomes
Council:

Marty Furch reported that the Learning Outcomes Council (LOC) met on Thursday, December 3. The group adopted a framework for General Education/ Institutional Student Learning Outcomes (SLOs) and Competencies. The document has been widely disseminated, and will be amended and updated as discussion occurs within the college community.

The LOC has a meeting scheduled with Cypress College on Tuesday, December 15, where they will meet with the SLO Coordinator and others to learn more about the implementation and use of TracDat. The Council hopes that the system will be up and running by the end of next semester.

Academic Honesty:

This issue will be discussed at a meeting early in the Spring Semester, as Senator Bruce Bishop was not present at today's meeting.

ASG:

There was no ASG representative present.

- President Deegan: Monika Brannick reported that at her weekly meeting with President Deegan, discussion focused on budget issues. Deegan has invited Senate Vice President Fari Towfiq to represent the Senate at a meeting with legislators in Sacramento on Monday, January 25, 2010.
- Governing Board: The next meeting of the Governing Board is scheduled for Tuesday, December 8. Monika Brannick stated that she will be providing a report regarding the college's progress in responding to Accreditation Recommendation #3 on Distance Education.
- Strategic Planning Council: Monika Brannick indicated that members of the Strategic Planning Council continue their work on their goals for the Strategic Plan and hope to have a draft early in the spring. The Resource Allocation Model will also be reviewed early in the spring.
- Instructional Planning Council: Fari Towfiq reported that the Instructional Planning Council (IPC) met on Wednesday, November 18. The group continued its work on Program Review and Planning, focusing on the Supplemental form and the process for review. Several recommendations are being made, and the item will be brought back for further discussion by IPC and the Facilities Planning Council in the spring semester.
- Student Services Planning Council: The next meeting of the Student Services Planning Council will be held on Wednesday, December 9.
- Other: A Senator called attention to the recent employment announcement for a Student Activities Coordinator and questioned the rationale for the proposed hire, particularly in light of the district's recent hiring freeze. Monika Brannick stated that she will seek further clarification of the matter.
- There was also a question as to whether the position of Information Services Director will be filled in the near future. A Senator pointed out that the position is currently being filled by a consultant, which has been a substantial ongoing cost to the district.
- Senators expressed frustration with the idea that non-faculty positions are being filled during a hiring freeze; many departments on campus are struggling, as the full-time faculty numbers are so depleted.
- Joint Senate/PFF Council: Barb Kelber stated that the Joint Senate/PFF Council would meet after today's Senate meeting. She invited all Senators to attend. The group is currently looking at formal agreements used at other colleges to delineate and formalize relations between Faculty Senates and Collective Bargaining Units, particularly with regard to overlapping jurisdictional issues.
- Kelber added that the Joint Council will meet on the 2nd and 4th Monday of each month. She reiterated that all faculty members are invited to attend these meetings.
- Palomar Faculty Federation: Jackie Martin-Klement provided the following report of the Palomar Faculty Federation:

The PFF eboard meeting regularly scheduled for this Thursday has been postponed until Tuesday, Dec. 15th. On that day the E-board and the negotiations team will meet in closed session to discuss negotiations and the Union's next counterproposal.

We delivered three letters to the District today. The three letters are as follows:

1. A "Demand to Bargain" letter for the use of the TracDat data. We want to bargain over the way that the data is gathered, stored, and used and any impacts that data might have on evaluations, working conditions or terms of employment.
2. A "Demand to Bargain" letter for an administrative policy that was brought to Policies and Procedures titled "Code of Ethics". The problem with ethics codes is that they sound great in theory but can become major disciplinary problems in practice. The questions we would want to bargain are these: Who gets to determine which behavior constitutes "ethical behavior"? How are those determinations made? Are they applied evenly throughout all constituency groups? Do they interfere with any guaranteed constitutional rights? Are there disciplinary consequences? What kinds of due process would apply? These are important questions we would want to make sure that we negotiate before endorsing such a policy.
3. A letter requesting information about the District's reporting of full-time faculty to the Chancellor's office. At a recent meeting of the Community College Council, union presidents were warned that CFT had recently become aware of serious reporting violations regarding the number of full-time faculty at college campuses across the state. We were encouraged to keep a close eye on that. In the fall of 2007, the District reported 296 full-time faculty and in the fall of 2008, the District reported 301 full-time faculty. The union is asking for detailed accounting of those numbers.

Learning Outcomes
Council:

Marty Furch stated that the Learning Outcomes Council met for their final meeting of the semester on Thursday, December 3. In addition to discussion on GE/SLOs the group discussed the Service Learning Committee. She stated that the LOC has expressed concern about filling another large committee. A recommendation will likely be brought forward next semester suggesting that the Service Learning Committee be reconfigured as a task force rather than a committee.

Furch also reported that the LOC, in coordination with the Office of Research and Planning, has developed a form for Department Chairs requesting that they provide information on how many courses in their departments have at least one Learning Outcome. In addition, the form will ask Chairs to indicate specific terms and dates for assessment of outcomes, as well as prospective terms/dates for reflecting on assessments in order to complete the cycle. That information will then be forwarded on to the Accreditation Steering Committee.
