§ 55003. Policies for Prerequisites, Corequisites and Advisories on Recommended Preparation.
(a) The governing board of a community college district may establish prerequisites, corequisites, and advisories on recommended preparation, but must do so in accordance with the provisions of this article. Nothing in this subchapter shall be construed to require a district to establish prerequisites, corequisites, or advisories on recommended preparation; provided however, that a prerequisite or corequisite shall be required if the course is to be offered for associate degree credit and the curriculum committee finds that the prerequisite or corequisite is necessary pursuant to sections 55002(a)(2)(D) or 55002(a)(2)(E). PFF Resolution
Opposing Privatization
Of Education:

Shannon Lienhart shared a resolution supported by the Palomar Faculty Federation (PFF) that opposes the privatization of public education and in particular seeks to ensure that before Palomar enters into educational contracts with private firms that these contracts be vetted by the Faculty Senate and the Palomar Faculty Federation. The resolution also asks that there be discipline-appropriate approval of proposed workshops and other activities by for-profit educational entities that may result in the recruitment of students. Lienhart noted that currently some not-for-credit courses do not require approval by the Curriculum Committee or the Faculty Senate because faculty teaching these courses are not employed by the district. Lienhart noted, however, that last year there was a move by the State Assembly to attempt to make some of these not-for-credit courses available for credit. The bill did not pass at that time, but there is concern that this issue will be brought back for reconsideration in the future. Although there are some valuable courses that can be taken as part of continuing education, there is a need for oversight by the Faculty Senate and PFF due to the implications for curriculum, students, and faculty.

Lienhart shared some examples of workshops held on campus from which students were actually recruited out of the community college system to for-profit colleges that charge exorbitant fees and offer different degree programs.

Senators noted that the Workforce Community Development Advisory Group, which is not currently meeting, was once the area in which such issues would be discussed. The Senate, the PFF, and the Board need to make some decisions on the direction this group is going. Currently, there is only one employee in Occupational and Non-Credit Programs overseeing this area, and its future is unknown. Discussion also occurred on the need for campus awareness of workshops or other activities which may result in recruitment of students by for-profit educational entities.

Lengthy discussion followed on the attempts being made to centralize education. Senate members agreed that there is a need to streamline a campus-wide process that is open, simple, and consistent. Although there was support for the resolution brought forward by the PFF, Senators recommended some minor changes to the wording.

This item will be brought back for Faculty Senate Action at next week's meeting. Shannon Lienhart indicated that she would be bringing it before the Governing Board in early April.

Policies & Procedures:

Barb Kelber provided an update on the current Policies & Procedures being discussed by the members of the Policies & Procedures Task Force.

BP 3410 – Nondiscrimination/AP3410 (Recommended Deletion) – Accepted

BP/AP 3430 – Prohibition of Harassment (previously tabled)

Kelber reminded Senators of their review of this document on several occasions. She placed it on the overhead and noted the changes being proposed, which are in line with the Senate's recommendations.

AP 3435 – Discrimination and Harassment Investigations Training
This procedure will be negotiated by the District and PFF.

BP 4030 – Academic Freedom – Complete

BP 7361 – Academic Due Process – Accepted

This policy is near completion. Classified staff will now have a separate policy for conflict resolution.

AP 3750 – Use of Copyrighted Material

This procedure is currently being reviewed by the Academic Technology Committee.

AP 5530 – Student Rights and Grievances

Kelber placed this procedure on the overhead and outlined the issues that still need to be addressed. This procedure will be brought back to the Senate.

AP 7120 – Recruitment and Hiring

This procedure is on hold until the document has been revised.

AP 4231 – Grade Changes

This procedure will be discussed at the next Policies & Procedures meeting. Barb Kelber placed the document on the overhead and noted the proposed changes. Senate members expressed concern with some of the proposed wording.

Changes to Academic
Calendar:

Teresa Laughlin reported that several faculty members provided feedback on the proposed changes to the Academic Calendar, changes which are necessary to bring Palomar into compliance for the required number of meeting hours. Laughlin indicated that members of the Negotiations Advisory Council have hosted a meeting on the issue, and Laughlin and Greg Larson have met with Berta Cuaron and Dean Judy Cater, as well as Vice Presidents Vernoy and Tortarolo. She will report on the outcome of the latest proposal next week, as a formal decision is yet to be made.

MOOCs:

This item will be discussed at next week's meeting.

Accreditation Team
Members Observing
Online Teaching:

Greg Larson reported on information currently being shared by two institutions that Accreditation team members have enrolled (as faculty) in online classes for monitoring purposes.

Senators discussed what appears to be a widespread fear by all districts of being sanctioned or placed on warning. It was also noted that this kind of monitoring is a direct violation of student privacy, of the Family Educational Rights and Privacy Act (FERPA). Senators Teresa Laughlin, Lillian Payn, Barb Kelber, and PFF Co-President Shannon Lienhart will work on a resolution to bring forward as Action at next week's meeting.

TERB Article 17:
Evaluations:

Barb Kelber distributed copies of an amended version of Article 17, Evaluations. She briefly discussed the proposed minor changes and heard input from Senate members, including one additional recommendation for a change in wording. This will be brought back for further discussion at next week's meeting.
