Also, there was a suggestion to define what<br>constitutes regular and substantive interaction between instructor and students in an<br>online class. Overall, the commission gave positive feedback on the report, and an<br>updated version will be resubmitted next week. |

| TERB: Revision of<br>Forms: | Barb Kelber distributed copies of a first draft of the revised Self-Evaluation Form. The document is being revised based on discussions with faculty, members of the Tenure & Evaluations Review Board (TERB), and the Palomar Faculty Federation (PFF). Kelber noted that the form has not been updated in 6-8 years. |                             | Kelber shared copies of the college's Mission Statement, noting the language relating to<br>learning outcomes. At last week's meeting, Kelber distributed copies of the Faculty Peer<br>Evaluation Report forms for full-time Counseling, Library, and Teaching faculty. There<br>was recently a revision to the part-time evaluation form, including the Department<br>Chair's Supplemental Form, which contains a question about Student Learning<br>Outcomes. TERB is working to refine how this supplemental form is used due to issues<br>relating to clarity during the process, particularly with multi-disciplinary departments.<br>The revised peer evaluations forms for both the full-time Counseling and Library faculty<br>now also include the same question on SLOs that is part of the part-time evaluation<br>forms. There has been talk of making changes to the documents providing a "yes" or<br>"no" option to some of the questions rather than maintaining the rankings, though more<br>discussion is needed due to other issues that will be raised with that change due to<br>variations in departments. Kelber noted the need for communication and collegiality in<br>the process, and TERBs continued effort to assist faculty who may be in need of<br>assistance. |
| Policies &<br>Procedures:   | Barb Kelber indicated that AP 7120, Recruitment and Hiring, will go back to Policies & Procedures for additional changes and clarification, including a change updating information on the Child Development Center Teachers. The Faculty Senate representatives sought clarification regarding the Compliance Officers and their attendance during all stages of the process, and the role of the Observers was also clarified to encourage consistency; it was noted that the Observers will be asked to comment on factual details only. Lastly, there was agreement that the approach to 2 <sup>nd</sup> level teaching demonstrations will remain the same, with no specific requirement in the language.
