Students will be empowered to actively engage in the exploration of real data and to anticipate patterns in a social context. Students will describe and interpret authentic data patterns and deviations from those patterns using graphical and numerical representations of their positionalities. Students will be exposed to probability and tests of statistical significance to explore social inequality such as systemic forms of racism, sexism, and other forms of social oppression. Using anti-oppressive principles, students will actively learn to use data in the pursuit of social justice and change. This course allows students to understand participatory action research, an activist approach that seeks to engage and empower the community. This course will also help to empower students to see their ideas reflected in quantitative analysis.
