End-of Year Report to Senate Academic Technology Committee, May 16, 2016

Committee members approved our summary of our goals for the past academic year.

 Recommendations for the Canvas pilot research design. (It should also be noted that at the most recent SDICCCA DE meeting on May 6, the Canvas report listed 70 community colleges in CA as having made a commitment to license Canvas, and over 10 more are in progress of licensing Canvas.) - We discussed OEI, but voted to postpone making a decision until our leadership positions were filled with permanent positions on campus.
- 3. We conducted a meta-analysis of class size for online classes. The committee researched a seminal, published document, which recommended that class size be set by the type of class. The following recommendations were made by the authors: Classes that were one-way communication to the students had no limits on attendance, but classes that included two-way communication between the faculty and students, and student to student recommended 25 students or less. If the model was "Community of Inquiry", a class size of 20 students or less. Courses that included lower levels of Bloom's Taxonomy should be 30 students or less, but courses that included higher levels of Bloom's Taxonomy with a full implementation of "Community of Inquiry" and constructivist techniques should be 15 students or less.
