CALL TO ORDER:	The meeting was called to order by the President, Travis Ritt, at 2:30 p.m. in Room SU-30.

Public Comments:	Dan Sourbeer stated that members of the ACCJC Internal Evaluations Team returned to campus today for their follow-up report. The meetings seemed to go well. Sourbeer thanked members of the writing team for their work.
Announcements:	Lori Waite invited all to attend a conversation with Alex Montoya, the Recipient of the Visionary Award from Cesar E. Chavez Committee. The event, sponsored by the Palomar College Student Success and Equity Council, encourages attendees to join the conversation about Montoya's journey in overcoming obstacles as a Latino with a disability and the role mentors play. It will be held November 2, from $2:00 - 4:00$ p.m. in the Performing Arts Complex, Studio Theater.
	Travis Ritt reminded Senators of Political Economy Days on Wednesday and Thursday, October 26 & 27. He noted Wednesday's event with Ian Ruskin, an actor trained in London at the Royal Academy of Dramatic Art, performing his one man show: "From Wharf Rats to Lords of the Docks," being held at the Howard Brubeck Theatre at 12:45 p.m.
	Jenny Fererro announced that Service Learning is sponsoring an event on Friday, November 4, providing faculty an opportunity to learn more about incorporating Service Learning into their syllabi. Compensation is provided for attending the event, and refreshments will be provided. Faculty should check their email for more information.

Agenda Changes: Travis Ritt indicated that Information Items C, AP 4260, and F, Religious-based Groups on Campus, would be postponed until next week's meeting.

PRP Form: Senate members were provided copies of the revised Comprehensive Instructional Program Review Template (PRP) for 2016-17. Michael Mufson provided information on the revisions being proposed, particularly the goal of making the document an authentic, self-reflection process for departments and disciplines. An attempt was also made to create efficiency and provide a process of productive feedback. The revision will separate the planning process from the resource request process in that there will be a second-step procedure for funding requests.

He noted that the changes were made, in part, to satisfy Accreditation requirements, but also with the hope of providing authentic and thorough opportunities for disciplines to communicate and plan for present and future needs. The timeline for the project is in-line with the three-year Strategic Planning Process and in an attempt for it to be meaningful and useful, the plan is to do a comprehensive review of only 1/3 of the disciplines at a time, and the other 2/3 will do an update on the previous year. The second year another 1/3 will do a comprehensive review, and the third year the last 1/3 will do theirs. How those groups will be chosen and in what order has yet to be determined. It is hoped that by creating this process more in-depth review and discussion can occur for each department.

A question and answer period followed. Senators were asked to contact Mufson, Travis Ritt, or Dan Sourbeer with any further questions or comments. This item will be brought back for Faculty Senate Action at next week's meeting.

Withdrawal Form: Kendyl Magnuson thanked Travis Ritt, Melinda Carrillo and Teresa Laughlin for their input on updating and revising the Petition for Withdrawal (W) form. Ritt, Carrillo, and Laughlin met with Magnuson several times over the last few months to revise the form as it relates to issues of confidentiality.

Copies of the revised documents were provided and brief discussion followed. Some minor amendments were recommended relating to documentation, confidentiality, and the choices offered for withdrawal. Magnuson asked that Senators contact him with any suggestions or concerns. This item will be brought back for Faculty Senate Action at next week's meeting.

Accreditation: Travis Ritt stated that he, Fari Towfiq, and Greg Larson met briefly with members of the Accreditation Team earlier in the day. Though the team was originally scheduled to attend the Senate meeting today it was determined that it was not necessary.

Statement of Service For Nancy Chadwick: Travis Ritt indicated that Governing Board member Nancy Chadwick will be retiring at the end of November after serving 13 years as a Trustee. He asked Senate members for input on providing recognition for Chadwick before her last meeting.

Speaking for the Palomar Faculty Federation (PFF), Shannon Lienhart added that members of the Cabinet and Furniture Technology created a beautiful gift for Chadwick. She suggested that the gift be given from the PFF and the Faculty Senate as a united faculty gift.

Senators agreed with the suggestion, and it was agreed that a joint statement from the Faculty Senate and PFF would be brought for Faculty Senate Action at next week's meeting.

Distance Education Offerings Resolution:

At last week's meeting, Senate members discussed the topic of Distance Education after Travis Ritt was contacted by some faculty members who felt they were being pushed to develop Distance Education courses even when they pedagogically disagreed with DE for particular courses. There was discussion on the importance of protecting departmental and faculty autonomy on issues relating to discipline expertise, and the issue of some disciplines or courses where distance education would not be as successful as a face-toface course or simply could not be done. At this week's meeting, the following Resolution was brought forward and discussed:

Motion 3 MSC Larson, Towfiq: Whereas, the development of curriculum falls under the purview of faculty, pursuant to the rules adopted by the Board of Governors of the California Community Colleges;

Whereas, the Palomar College Governing Board has elected to rely primarily on the Faculty and the judgment of the Faculty Senate on academic and professional matters;

Whereas, the Faculty Senate of Palomar College relies on discipline experts to determine the pedagogical effectiveness of delivery methodologies in their area of expertise;

Whereas, the development of distance education curriculum in all formats falls under the above categories;

Let it be resolved, that the Faculty Senate supports the practice of faculty primacy in the development of all distance education related curriculum;

And further let it be resolved, that the Faculty Senate asserts the expectation that all changes to curriculum be initiated by discipline experts from within the faculty, regardless of the requests of deans or other administrators.

The motion carried.

Tutoring Committee:

Online tutoring for online, Camp Pendleton, and self-taught students with our tutors and NetTutor began on August 29. Online tutoring for all other subjects with NetTutor (and in the case of English, a combo of NetTutor and our tutors) began on Thursday, September 7. Students in every organization on Blackboard were sent an announcement email letting them know they had access to online tutoring on Friday, September 8. All students in every organization were also sent a reminder announcement email (and to let the Fast Track Two students know they had this access) on Wednesday, October 19. Senate President Report: Travis Ritt indicated that he has attended his scheduled meetings with Dr. Blake and Vice President Sourbeer. He noted that Dr. Blake is looking forward to the return of Campus Explorations, and that he will be meeting with Barb Kelber, who led the program previously, later in the week to discuss the role of the faculty coordinator. More research will also be done on offering release time for the position. Strategic Planning Council: Reporting on the Strategic Planning Council, Travis Ritt stated that a payment plan for students goes into effect on October 31. The first report from the marketing company was also discussed, particularly as it relates to contacting the college by phone, our website information, our application process, and how that data compares to other colleges. The Enrollment Management Group will begin meeting again. Those who were serving on the committee when it disbanded will be contacted to see if they are interested in continuing their service. Co-chairs will be Margie Fritch and Travis Ritt. Members of the Budget sub-committee and the Faculty Senate sub-committees on Enrollment Management will also be added to the group. Instructional Planning Council: A Senator is needed to serve on the Instructional Planning Council.

Erin Feld provided the following report of the Tutoring Committee:

Palomar Faculty Federation (PFF):	Shannon Lienhart stated that members of the PFF continue their work on the upcoming elections. A grievance that was previously filed on class cancellations has been moved from step 1 to step 2 due to no response from the deans.
	Lienhart added that the PFF has received 12 complaints from faculty in a period of two months about AMBCS Dean Hussain.
Budget Committee:	Joel Glassman provided the following report of the Budget Committee:
	The 2016-17 budget was approved by the Governing Board with a funding balance of approximately \$34 million; a \$4 million loss results in \$30 million anticipated to be left.
	If Proposition 55 does not pass, the district's budget could be affected negatively by approximately \$15 million.
Student Services	
Equity Council:	Travis Ritt reported that the Members of the Student Services Equity Council have reviewed all funding requests. All submissions who met the parameters for funding were approved.
Strong Workforce:	Jackie Martin stated that she and Molly Faulkner are the faculty liaisons of the Strong Workforce group, and Barbara Blanchard and Margie Fritch are the administrators.
	Martin also stated that she attended the Regional meeting on Friday, October 21 and was the only faculty member from the area in attendance. She stressed the importance of faculty participation on the workforce as funding for Palomar and other districts are at stake.
	Travis Ritt added that the Statewide Academic Senate will vote on a Resolution at their upcoming Fall Session pushing local Senates to identify a faculty liaison to participate in those regional bodies.
Academic Technology Committee:	Lillian Payn stated that members of the Learning Management System Task Force had their first meeting last week.
Basic Skills Committee:	Lori Waite reported that members of the Basic Skills Initiative (BSI) Committee continue to discuss their annual goals. There is widespread unanimous support from the committee to get Palomar more engaged in BSI not just from its own coordinators but in the entire region. It is hoped that the BSI can consider hosting the meeting of the Southern Region for the Statewide Academic Senate Basic Skills Committee for Contextualized Teaching and Learning on December 3.
Articulation:	Ben Mudgett indicated that he recently attended the Statewide Academic Senate's Regional Curriculum meeting for the Southern region. They reported that the ASCCC will be holding workgroup meetings beginning in December and going through the Spring meeting regarding local Curriculum processes. He referred to the Statewide Academic Senate's recent article in the October edition of the Rostrum (http://www.asccc.org/publications/rostrum) on streamlining the process.

He added that he also attended the Dual Enrollment Breakout Session where discussion focused on content and assuring that students have reached the appropriate level of maturity.

Issues relating to CCAP, course cancellations, and non-credit were also addressed. Mudgett added that there was discussion on non-credit courses and the fact that they are bringing the community back into community colleges by encouraging and promoting engagement within the community.

ADJOURNMENT: The meeting was adjourned at 3:50 p.m.
