CALL TO ORDER: The meeting was called to order by the President, Travis Ritt, at 2:30 p.m. in Room SU-

30.

Approval of Minutes:

Motion 1 MSC Carrillo, Glassman: Faculty Senate approval of the minutes of April 17, 2017, as

presented. The motion carried. Abstention: O'Brien

Public Comments: There were no public comments.

Announcements: Travis Ritt reminded Senators that elections for Faculty Senate Vice President and

Secretary will be held at the May 8 meeting. He stated that it is hoped that whoever steps into the position of Vice President will be willing to shadow him his last year as Senate President and be prepared to step into the role of Senate President when his term ends in

2018.

Travis Ritt announced that next week's Senate meeting may be held in the Industrial

Technology Center on campus.

Agenda Changes: No changes were proposed to the Agenda.

Phi Theta Kappa Project on the Food Bank:

Forrest Ponsot, President of the Honors Society of Phi Theta Kappa, shared information with Senate members on the expansion of the Palomar College Food Bank. Though the district currently houses a small food bank by the Veterans Center in the SU building, the area is not large enough to provide a well-stocked pantry to accommodate the number of students who may be in need. He added that beginning next semester the area commonly referred to as the staff lounge behind the cafeteria will become the new food bank. This larger space will enable the College to provide more product.

Ponsot shared local statistics on those in need, as well as information on the process of how the food is collected and disbursed.

Because it can be difficult to get the word out to students, he is asking that faculty members share this information in their classes, on their syllabus, and/or on departmental webpages. Volunteers will also be needed and can receive Service Learning Hours.

A question and answer period followed. Senators offered suggestions on the application process for students as well as how food collected could potentially be expanded by soliciting local companies. Anyone wishing to receive more information, including how to donate, should contact Sherry Titus for more information.

FSAs:

Senators received copies of Faculty Service Area (FSA) forms for the following departments:

Chemistry

Counseling, Guidance and Career Development

Physics and Engineering

Greg Larson informed Senate members that several updated FSAs were approved at the last Governing Board meeting. These three FSAs will be brought forward at their next meeting after being approved by the Faculty Senate. Brief discussion followed on the process.

Larson noted that all FSAs were previously listed in the Governing Board Manual, which has not been updated for several years. Beginning soon, they will all be posted on the Faculty Senate website.

Travis Ritt added that a Senator will be needed to chair the Faculty Service Area committee beginning next semester.

BP/AP on Harassment:

Copies of AP and BP 3430, Prohibition of Harassment, were provided. Discussion occurred on the section related to bullying and the challenges in defining bullying, which can vary from person to person based on several varying factors. It was noted that harassment is defined by state law and covers bullying; therefore, technically the two terms can be interchanged and the addition of the proposed wording is not needed.

After further discussion, there was agreement that Faculty Senate representatives serving on Policies & Procedures should share the Senate's concerns on how the policy is currently being proposed and vote against its implementation.

Baccalaureate Degree at Palomar:

Travis Ritt reminded Senators of a pilot project that was put into effect several years ago by the State of California sunsetting in 2019 to explore and to offer Baccalaureate degrees at varying community colleges (with the exception of Nursing) as well as not allowing any degree to be offered within 100 miles of a CSU that was offering the comparable degree. Since that time, 10 of the 15 pilot schools are in process, and 5 will begin in the fall. According to data shared at the recent Statewide Academic Senate Spring Session, to date approximately 200 students attending the 10 pilot schools have participated in those programs. He added that there is current legislation being proposed that would extend the expiration of the pilot until 2022 with the potential to expand from a pilot to a full program. This would allow more colleges the opportunity to offer these Baccalaureate degrees. The Statewide Academic Senate is lobbying against the proposal due to insufficient data being

available on the success of the program.

Palomar has expressed interest in participating, and the Institutional Research and Planning area will soon begin the study of what degrees could benefit our students.

Senators discussed the need for departmental and faculty input and whether it fits into Palomar's mission statement. Issues such as minimum qualifications, faculty load, and tenure requirements need to be discussed as well. Ritt added that the ACCJC has received an extension to grant Accreditation to colleges that have one or fewer Baccalaureate degrees.

Title V Grant to Develop Education ADT:

At last week's meeting, Senators heard information on a Title V Grant to Develop Education ADT. The Senate did express some concern that the process was moving ahead very quickly with little opportunity for faculty discussion and input, particularly from those departments who will be participating or affected.

Travis Ritt stated that the application process has moved forward and the proposal was submitted to the State for consideration.

State Academic Senate Spring Plenary:

Travis Ritt informed Senators that he attended the State Academic Senate Spring Plenary session on Thursday, April 20 – Saturday, April 22. He noted his attendance at a breakout session on Diversity and Hiring and that Palomar's current policy on Faculty Hiring was praised for its influence by faculty throughout the process. Senate members acknowledged Barb Kelber for all her work on the policy.
