CALL TO ORDER: The meeting was called to order by the President, Travis Ritt, at 2:30 p.m. in Room SU-30.

Approval of Minutes:

Motion 1 MSC Thompson, Nelson: Faculty Senate approval of the minutes of September 18, 2017, as presented. The motion carried. Abstention: Cunningham

Public Comments: There were no public comments.

Announcements: Travis Ritt expressed his thanks to Candace Rose for overseeing last week's meeting due to his absence and Senators acknowledged Rose's efficiency in running the meeting.

Teresa Laughlin reminded all that the Palomar Faculty Federation (PFF) is holding focus groups for faculty to provide feedback to the PFF about how the PFF can work for all faculty. Faculty are invited to attend the focus groups being held at the following times: Tuesday, October 3 and Wednesday, October 4 at 7:00am, 10:00am, 3:00pm, 4:00pm, 5:00pm, and 6:00pm. Agenda Changes: Travis Ritt noted that there may be changes to the Agenda as we attempt to accommodate our guests who will be discussing Information items B and E.

Implementation
Grant ZTC:

Kelly Falcone indicated that though it was initially thought that the district would not pursue the Zero-Textbook-Cost (ATC) Implementation Grant, a "Z-degree" or "zero-textbook-cost degree" grant, there was interest expressed by faculty in Journalism who agreed to oversee the process. Erin Hiro added that the department currently has two one-year fully online certificates (Public Relations and Journalism), which are not high-traffic majors and are not transferrable to every institution. It is hoped this grant will provide an opportunity to market to this particular population of students.

Wendy Nelson added clarification on how the grant would benefit students, including the opportunity to provide funding for office hours, course designers, marketing, and student workers.

A brief question and answer period followed.

SSEC/BSI Integration

Draft:

Olga Diaz presented information to the Senate on the 2017-19 Integrated Plan: Basic Skills Initiative, Student Equity, and Student Success and Program. The integrated SSSP/Student Equity/BSI program model promotes integrated planning and program coordination at the district and college levels. The three programs retain separate requirements as specified in Education Code and Title 5 regulations; these requirements are built into the Integrated Plan to ensure compliance with applicable law and regulations.

Plans are to be developed in consultation with students, staff, administrators, faculty, Academic Senate, and members of the community as appropriate. Plans must be adopted by the Governing Board of the Community College district and submitted to the Chancellor's Office by December 1, 2017, and a separate plan must be submitted for each college in the district.

Deadlines and Important Information:

- The 2017-19 Integrated Plan will cover two years. The budget plan will reflect the 2017-18 allocations.
- Integrated fiscal reports will be required on an annual basis.
- All programmatic and student outcome data will be collected via existing MIS reporting. No additional data submissions are required.
- Colleges are encouraged to align integrated program plans with their college and district strategic plans/education master plans.
- Identify one individual and one alternate to serve as the point of contact for each college.

Resolution on Shared Governance in the

Hiring Process:

Copies of a draft of a resolution on Shared Governance in the Hiring Process was shared on the overhead. Senators were reminded of last week's discussion regarding Board Policy on the issue of faculty hiring, particularly the importance of a collegial shared governance process which provides an opportunity for open dialogue and collective decisions.

Brief discussion followed. Senators were asked to forward their comments and/or suggestions for change to Travis Ritt who will bring them to next week's meeting for group discussion and Action.

Non-voting Members on
Functional Committees:

Vice President Kahn talked about the district's current committee structure and noted some potential inefficiencies in committees limited to faculty or administrative membership. He asked the Senate to discuss and consider including non-voting staff, directors, deans or administrators on some committees or councils as there are instances when issues are discussed that could benefit from their input. He asked that at this time the Senate discuss amending the membership structure of the Academic Technology Committee to add one or more non-voting positions for administrators or deans. He added that although the meetings are open to all, allowing an expanded membership would improve the spirit of improved communication and cooperation.

Kahn was asked which other committees would be considered for this change. He indicated perhaps the Curriculum Committee and the Learning Outcomes Council. Discussion followed on the challenges involved with a larger membership other than just having these massive committees; including the issue some committees currently face with meeting a quorum. After additional discussion, Senate members agreed that each committee or council should independently make the determination of whether they wish to make any changes to their membership structure, and bring those structure change requests to the Senate.

New Training Proposal
Template:

Copies of a New Training Proposal Template (Not-for-Credit) were distributed. Jackie Martin noted the changes to the document that will provide an efficient process for non-credit courses and Contract Education.

Discussion followed on the process of offering these courses, or training, as well as how the payment structure utilized for instructors teaching the courses occurs, and the need to clarify non-credit vs not-for-credit.

This item will remain on the Agenda for further discussion at next week's meeting.

Wendy Nelson informed Senators that members of the Curriculum Committee discussed adding two administrative positions to their membership structure: The Associate Dean of Career and Extended Education (currently Nichol Roe), who will be a voting member, and the Director of Non-Credit (currently Suzanne Sebring), a non-voting member.

Nelson will bring that change of committee membership structure to the Senate for Action at next week’s meeting. Some discussion occurred on whether both positions should be voting members.

Faculty Senate
 President Report:

Travis Ritt stated that he had meetings with both Vice President Kahn and President Blake last week to discuss the Faculty Hiring Policy.

Candace Rose added that she met with Dr. Blake last week and discussed the “It Adds Up” campaign, which is the district’s effort to encourage part-time students to consider full-time enrollment. There was also discussion on the creation of a county-wide e-Newsletter that is being created titled “Palomar News.” She added that work also continues on a publication to recruit students through the Business and Industry areas.

Travis Ritt added that he will be attending the Student Success and Equity CUE Diversity in Hiring Symposium in Los Angeles on Wednesday, September 27 – Friday, September 29.

Strategic Planning
Council:

Members of the Strategic Planning Council met on Tuesday, September 19. The group discussed whether there would be a continuation of our food service provider Aramark's contract.

The possibility of providing holidays for Cesar Chavez and Native American Day will also be forwarded to the Palomar Faculty Federation (PFF) for negotiations.

Distance Education &
Academic Technology:

Lillian Payn provided the following Distance Education & Academic Technology report:

1. BB closes at the end of the semester. Reminder to prepare for transfer early since we shall not be able to add more staff over winter break to assist instructors with their migration. Please back up (archive/export courses in BB), and save off grades as excel spreadsheet in case there is a grade dispute. In the event you did not do either of these, bring in the archive/export zip file (unopened), so the ATRC staff can extract the grades. Please distribute this information. (Only Canvas will be available as of Winter Intersession, January 2018)

2. Referencing the Motion 7 (MSC) at Faculty Senate meeting May 20, 2013, regarding access levels for interpreters, TERB Coordinator Lesley Williams requests a similar access for Evaluators fulfilling Online Evaluation responsibilities.

To review the Interpreter settings: This is now an "NI" (Non-Instruction) checkbox in the SIS sheet, with no access to grades or student information, but allowed to comment as needed to assist a student.

Similar to this setting is the requested Evaluator setting. Canvas has an "Observer" setting that fits TERB requirements (and complies with FERPA): no access to grades, student information, or communication to students.

(Note that while the ATRC staff can set up the access within Canvas itself, the SIS sheet where the personnel formally gains the permission is an Instruction Office responsibility, and then PeopleSoft staff actually assign the NI/Observer staff within the corresponding Canvas course. ATRC is coordinating with the Instruction Office and PeopleSoft staff.)

3. Canvas Transitions Summary Session on Wed, Sept 27. From 11 to 12 noon. At the recommendation of the DE & AT Committee, we shall include Tips and Techniques about Backing up BB, Using Unicheck Plagiarism Detection, and Specifying Account Settings in Canvas.

Basic Skills

Steering Committee: Lori Waite reported that the Basic Skills Steering Committee is working diligently on the Basic Skills Component of the Integrated Plan.

Other: Kelly Falcone reported that work is ongoing on identifying not only no-cost textbooks but also low-cost textbooks. She and April Cunningham have been working to create a logo and link for that information. A low-cost textbook is considered one a student can purchase for \$40 or less.
