Faculty Service Areas:

Senators were provided copies of Faculty Service Area (FSA) forms for Kinesiology and Emergency Medical Education.

Fari Towfiq noted that three of the four FSA forms were being submitted from the Kinesiology, Health and Recreation department and contained very minor changes to the wording. Senate members noted the omission of a descriptor of the current FSA to the form for Emergency Medical Education. After brief discussion, there was agreement to support the FSA forms for Kinesiology, Health & Recreation and request that more information be provided for the proposed FSA for Emergency Medical Education.

DE&AT Committee Recommendation Regarding inviting Non-Faculty Members To Faculty Committees:

At the September 25 Faculty Senate meeting, Vice President Kahn talked about the district's current committee structure and noted some potential inefficiencies in committees limited to faculty or administrative membership. He asked the Senate to discuss and consider including non-voting staff, directors, deans or administrators on some committees or councils as there are instances when issues are discussed that could benefit from their input.

Lillian Payn indicated that members of the Distance Education & Academic Technology Committee discussed this request at their September 28 meeting and Payn shared the outcome of that discussion. The following recommendation was made (approved by unanimous vote) to the Faculty Senate:

- a. No more than two Non-Faculty members be invited to join the committee.
- b. Administration and staff members shall not be assigned or appointed due to the position held, but rather, membership be open to interested potential members with a passion for distance education and academic technology who shall request to be appointed by the Faculty Senate.
- c. Non-faculty members will not be part of the quorum.
- d. Non-faculty members will be non-voting members.
- e. A term limit was not specified.

Senate members discussed the recommendation, and though many agreed that a formal inclusion in the membership may provide an opportunity for improved communication, others wondered if it is necessary to change the committee structure to include members who will be non-voting members. Meetings of the DE&AT committee are open meetings and all faculty and staff are welcome to attend. It was also noted that this is a Faculty Senate committee, whose structure is outlined in our current Constitution to assure that it is faculty driven. If an issue is on the Agenda that is of interest to any faculty, staff, or administrator, they are welcome to attend any meeting as a guest. There was agreement that there is a need for improved communication on campus, but Senators opinions varied on whether changing committee structures was an appropriate step to take in that process.

This item will be brought back for Faculty Senate Action at next week's meeting.

Course Audits:

Seth San Juan stated that members of the Instructional Planning Council discussed audits at their last meeting. Dean Sivert indicated that there needs to be discussion on whether the college is largely denying audits, and whether we should have verbiage in the catalog and in our policies and procedures stating whether auditing is allowed and the guidelines for approving audit requests. This will provide a consistency across all divisions for all

Starfish Presentation:

Cynthia Anfinson and Nancy Moreno provided information on the Starfish Early Alert System, a new program being piloted by the Math department that facilitates two-way communication and offers easy ability to connect students to campus resources such as financial aid, counseling, behavioral health, tutoring, and others. Guided by SB539, Guided Pathways, the goal is to connect students to expanded campus resources to aid in their success.

Anfinson shared examples on the overhead of a customized site that faculty can create for their students. What has yet to be determined is how a timeline will be distributed to service areas and who will oversee the work involved in the process as a whole. A brief question and answer period followed.

Election for Open Part-Time Senator Seat:

Travis Ritt informed Senators that there is currently an opening for a part-time Senator on the Faculty Senate due to a recent Senator resignation. He asked for input on whether a call should go out now to fill the position or wait until next semester. Senate members agreed that the call should be sent to part-time faculty to fill the position immediately.
