# Senate Resolution on Textbook Affordability:

Kelly Falcone informed Senate members of AB 798, the College Textbook Affordability Act; a grant which would provide resources for colleges to promote the consideration of Open Educational Resources by faculty. A provision in the grant requires local academic senate approval for any program established through these funds, and each college will set their own benchmarks to account for use of the funds.

After brief discussion, Senators will review the Resolution passed by the Statewide Academic Senate and this will be brought back for Action at next week's meeting.

Title V STEM Steering Committee:

Cynthia Anfinson shared information on the overhead on a Title V STEM Grant, a 5-year grant shared with Cal State San Marcos that began in October of 2016 and will expire in September 2021.

She shared information on the goals, activities, and what has been accomplished to date. The grant requires a Title V STEM Steering Committee, which will fall under the Faculty Senate in the governance structure. A proposed membership structure was shared with Senators for information.

Anfinson also noted that the grant provides two non-institutionalized positions: Title V Grant Project Supervisor

Title V Administrative Specialist II.

There are also faculty release time positions available:
Student Pathways Coordinator (60% release time)
STEM CORE & Guided Pathways Facilitator (40% release time)
Program and Curriculum Coordinator (to include math acceleration) (40% release time)
ESL Acceleration Lead (20% release time)

A brief question and answer period followed.

This item will be brought back for Faculty Senate Action on March 5.

Scheduling: Face to Face vs. Distance Ed:

Senators discussed the increase in distance education courses and how some departments on campus are being affected. Because the needs of students vary, it is important to offer appropriate courses to those students who may need face-to-face interaction to be successful. One Senator noted wording in the district's mission, "To provide an engaging teaching and learning environment for students of diverse origins, experiences, needs, abilities, and goals."

Senators felt that some mixed messages were being received from administrators on faculty's role in the process of selecting the modality of their courses. Faculty, as discipline experts, can make the best determination of how a class should be offered to provide the best, most positive experience for their students. Comments were made about the impact to veterans, who can lose partial funding if all of their courses are scheduled online, as well as students with special needs who benefit from a classroom experience.

Lengthy discussion followed on several issues, and while Senators acknowledge there is a demand and need for online courses, there should be a give and take of information and ideas from departments, deans, and administrators as efforts are made to meet the needs of Palomar's diverse body of students. There is also consensus that there is a need for clarification on the amount of faculty autonomy and a need for more discussion on the impacts of faculty online load.

This item will be brought back for further discussion at next week's meeting.

Policies & Procedures:

The next meeting of the Policies & Procedures Committee will be held on Friday, March 2.

Faculty Senate President Report:

Travis Ritt reported that he continues to meet with Dr. Blake for their bi-monthly meetings. They will discuss the Nationwide Walkout scheduled for March 14 in support of gun control. Though some faculty members have indicated that they will step out of their classes for 5-10 minutes, no formal action is planned. It is hoped that the district will release some form of institutional statement on this issue.

He indicated that he also has his scheduled meeting with Vice President Kahn on Tuesday, February 27. He will share the Senate's discussion on Distance Education from this meeting and hopefully receive some feedback.

Governing Board:

The Governing Board will hold their next meeting on Tuesday, February 27.

Strategic Planning Council:

Members of the Strategic Planning Council recently passed motions in support of Guided Pathways and discussed the Staffing Plan.

Student Services Planning Council:

Barb Kelber submitted the following written report of the February 14 Strategic Planning Council meeting:

AB 19 – this legislation will provide free first-year tuition at community colleges throughout the state to eligible applicants. Palomar plans to continue the local Promise Program in conjunction with AB 19.

Window for input regarding Guided Pathways plan is closing soon. Goes to the Board at a special meeting, Feb. 27.

Review of funding requests from SS Division PRPs. VP Gonzales says there'll no new money, but there might be a bit left in SPFF funds from last year.

Notable requests: Police are asking for rifle-rated ballistic vests and shields in case of an active shooter scenario. Also, they would like crowd-control protective shields.

Police cars are needed for the North and South Centers.

VP Gonzales noted that the number of police officers should be around 15. We currently have 9. Also seeking funding to outfit two police cars with digital license-plate readers and would like to move to online parking permits.

The state has approved an increase in the cost of parking permits under the BOG program.

New discipline software in Student Affairs called "Maxient." Tracking and communication.

Enrollment services is on track to adopt a CRM (Customer Relations Management) System. Also for communication, marketing, etc,

Question from counseling: should we/can we do career-aptitude tests at the same time students are placed in English and Math?

Considering mandatory orientation for students.

Shauna Moriarty wrote a grant for funding for Mental Health projects. \$250,000 over 28 months. A Coordinator will be hired. Long term, the Health Fee will be used to maintain the position.

Kendyl Magnuson asks that the calendar work/negotiation be completed as soon as possible in order to move forward with Registration planning.

Push students toward scholarship because there are MANY available. Direct students to financial aid or e-services to apply.

A business-process analyst will come in as a consultant (probably from "Strata") to examine hiring processes.

Plans for "The Hub" in the old Veteran's Center are underway through Student Affairs. Sounds cool. A resource-based center helping students with Cal-Fresh, clothing needs, etc. Attention to homeless students through the Alliance for Regional Solutions.

Deadline for applications for the Promise Program is March 2.

Finance & Administrative Service Planning

Committee: Members of the Finance & Administrative Service Planning Committee are currently

discussing a revision of the Facilities Master Plan, as well as how the proposed budget

allocation will proceed.

Palomar Faculty

Federation (PFF): Teresa Laughlin invited all to attend the PFF meetings on the 2<sup>nd</sup> & 4<sup>th</sup> Tuesdays of each

month from 4:00-6:00 p.m. The first Tuesday the meetings are held at the off-campus location; and the fourth meeting of the month is held here at the main campus. Faculty are encouraged to keep up-to-date on the PFF by vising their website at:

Budget Committee: Teresa Laughlin reported that the sub-group of the Budget Committee was scheduled to

meet on the second Tuesday of the month but that meeting was cancelled.

Student Success & Equity Committee:

Travis Ritt indicated that members of the Student Success & Equity Group discussed workgroup formations and task forces and the need for follow-through of assigned tasks

relating to the plan and move it toward completion. The creation of ad-hoc groups was

discussed to assist the committee in this process.

Distance Education & Academic Technology

Lillian Payn submitted the following written report from DEATC:

1. Dean Ly attended the Feb. 22 meeting to meet the members, become acquainted with our role, tasks, and goals, and explore how she can facilitate our goals.

2. Dr. Manea discussed the Single Sign-On (SSO) transition. He reported that the college is making good progress in a short time since about 50% of the students and faculty using Canvas have already set up their new ID. The roll out to SSO includes e-mail announcements, college website announcements, and special sessions to help target audiences on campus.

3.The Accessibility Pilot, which will determine the best process for ensuring that our faculty online classes comply with ADA and Section 508, has 16 faculty participants. Tera Lisicky, our Instructional Designer, has been tasked to lead the pilot. Tera recommended some options to collect data and document students using the sites in the pilot. There are several options for filming students as they navigate the sites. Sherry Goldsmith offered valuable input as to what would be useful as well as realistic.

Sherry said that, while eServices is compliant with Section 508. Registration in general needs to be redesigned since it is challenging for all students, not only those using assistive devices. It is not an accessibility issue, but a human factors/usability issue. Another issue that students are facing is Palomar e-mail. As a Web-based system, it doesn't work with screen readers or Jaws. The application Outlook 365 is functional. Students who need to use Palomar e-mail on the Web cannot access it, thus missing all communications from instructors that are sent via e-mail. What can be done to remedy this?

Also, Sherry recommends that we have a policy across campus about the use of Publisher's content, since some content is compliant, others are not, even within the same publishing company. We discussed this issue with Dean Ly, who agreed that the Deans could be instrumental in communication the need and reasons to comply to the faculty in their divisions. Dean Ly pointed out that the OER materials that are already available from Open Stax, for example, are accessible. This is another reason to encourage faculty to adopt OER content. Sherry also recommended looking at companies that participate in "Voluntary Technology Standards."

- 4. POET status: 26 certificates so far this academic year, with 166 certificates total since POET was launched in January, 2012.
- 5. Canvas status: Over ½ of the scheduled courses are published in Canvas. This is less than the over 60% level of LMS usage as when we were using both BB and Canvas.

ADJOURNMENT: The meeting was adjourned at 3:50 p.m.
