# Report on Starfish Early Alert:

Cynthia Anfinson provided an update on the Starfish Fall 2018 Campus-wide Early Alert Pilot:

- All classes participated in the pilot
- 6 PD workshops were held to train faculty
- Training materials were sent out via email
- Questions answered via email/phone/in person
- Online training video is available in the 3PD Portal.

Anfinson shared information on faculty feedback and issues raised by the Fall pilot, as well as faculty suggestions received thus far. The Fall 2018 Student Dashboard Pilot is also underway, with three students participating. All are current or former student workers. Student access has been an issue due to those with a role as both a student and staff, and work continues to resolve that issue.

## Faculty Senate Goals:

At last week's meeting, Senate members discussed their progress on the 2017-18 Goals, as well as how to move forward for this academic year. At today's meeting, Senators met in small groups to review and discuss recommendations based on comments received from the recent survey and last week's meeting.

Discussion occurred on the following:

- The need to add wording to reiterate the Senate's dedication to Diversity in hiring to the Faculty Hiring Procedure.
- Ensure that faculty voices are heard during the process of hiring new faculty members.
- The need for a faculty/administrative balance on all levels of hiring committees.
- The need for a mechanism to follow-up on issues brought to the Senate.
- The current process for voting for committee appointments. This could fall under the goal of updating the Committee on Committee guidelines.
- Provide a clear understanding of Service Points and institutional responsibility.
- Should the Senate investigate a different location to hold the Faculty Senate meetings?
- Invite a Statewide Academic Senate representative to come to campus to share with faculty and administration the role of the Senate on campus.
- Make an effort to build a relationship with the Governing Board by inviting them to a Senate meeting once per semester. Teresa Laughlin indicated that the union will work with the Senate on this. A joint meeting with the PFF and Senate is currently scheduled for November.
- The need for Senate involvement in Guided Pathways.
- A place and time for faculty to get together outside meetings and the classroom.
- Senate involvement in advocating for students by identifying barriers that impede student success.

Senate members will meet in groups to prioritize and discuss how to move forward. This item will remain on the Agenda for further discussion next week.

Policies & Procedures:

Reporting on Policies & Procedures, Jenny Fererro indicated that AP 4105, Distance Education, was tabled last Spring at the Senate's request due to anticipated Title 5 updates. Those updates occurred but no feedback was received. Senate members will receive an electronic copy to review to take another look at it.

AP and BP 4070, Course Auditing and Course Auditing Fees will be presented at the next Policies & Procedures Committee for second review. Senators will receive an electronic copy of this as well to provide input and recommendations.

Faculty Senate President Report:

Travis Ritt reported that he met with Vice Presidents Kahn and Norman, and Tenure & Evaluations Review Board (TERB) Coordinator Lawrence Lawson last week to discuss the upcoming faculty hires and how members of TERB will receive support with the increased workload. Some hourly funds have been allocated to TERB to extend the current Administrative Specialist's hours. There is also the possibility of adding an hourly position as well.

Ritt also indicated that there was discussion on the truncated nature of the recent position announcements. Of the eight positions being filled, no departments elected to defer the process and will be brought to the Governing Board at the October 9 meeting. The closing date for applications will be October 29. Committees will receive applications the week of November 12, and will begin interviews the week of November 26.

Palomar Faculty Federation (PFF)

Teresa Laughlin reported that this week's regular PFF meeting will be held at Cocina del Charro in Restaurant Row, San Marcos. The patio is reserved from 3:30-6:30 p.m., with the meeting beginning at 4:00 p.m. Appetizers and beverages will be served, and all PFF members are welcome.

A negotiations Listening Session will be held on Wednesday, October 10, from 4:00-5:00 p.m. in MD157 for all full-time faculty.

Written Reports:

The following written reports were received:

Facilities Review Committee:

Candace Rose provided the following report of the Facilities Review Committee (FRC):

- Rancho Bernardo solar panels are in, which will eventually cover about 70% of the power down there.
- SDG&E are close to putting in electric car charging stations at the San Marcos, Escondido and Rancho Bernardo campuses. They are holding off on Fallbrook until the permanent buildings go in.
  - These stations do not cost the college anything. The ones on the main campus will be in front of the police station. People with electric cars set up an account with SDG&E directly, and the electricity usage is charged/accounted for before the campus is metered/charged for its usage so no double charge.
- The library faculty/staff are meeting this week to discuss their move to the new LRC.

- In November, M&O and the Police will be testing every alarm system on campus to make sure
  the alarms are "talking to" the main switchboard systems in both locations. We will get notice
  of this in advance.
- The Police will be moving into their new building by the end of October, except for dispatch they will be the last to move in.
- After the Alarm system check, M&O will starting moving into their building in Nov/Dec.
- Food Pantry grand opening on Oct 29th
- Prop M
  - T building storage (3 buildings) are out to bid. About 20 contractors showed up to bid - great turnout.
  - Arboretum phase 1 starting with the ADA path hopefully break ground in January
- If your department has some general notes for the Master Facilities Plan send these to Dennis.
- For suggestions on the usage of the old library building, send suggestions to your Dean to discuss with the Executive team.
- FRC is updating their committee organization structure. The Chair is now the Manager, Construction & Facilities Planning (Dennis Astl) and the Director of Facilities (Chris Miller) is now a member.
- The role of the FRC Governance Structure was also updated to better reflect the task of the committee.

# Distance Education Committee:

#### Distance Education Faculty Senate Report (10/8/2018)

- 1. Met with Dean Ly, and continued development of an Accessibility Primer and Getting Started guide.
- 2. Met with Dean Ly's "Online Student Success" group and discussed ways to ensure that students are prepared to succeed with online training. A key finding was that most of the information related to Distance Education is scattered in many places on Palomar College's web site and that we should create a Distance Education Portal that can be a "one-stop shop" for all things related to DF

I have begun working with Kelly Helming, in the ATRC, to develop this portal and we will be asking permission to include the "Distance Education" link with the other links at the top of Palomar College's Home page.

- 3. The Distance Education Committee met on Wed afternoon, 10/3, and discussed more about the Web Accessibility roll-out planning and the Accessibility Checklist (on the Palomar website). It is likely that the big push for promoting accessibility training and compliance will begin with the start of the Spring semester. A key finding was that it would be a good idea promote a "preview of coming attractions" in early December to give faculty a chance to begin to think about what they may need to handle regarding accessibility issues before the Spring roll-out.
- 4. I will meet with Kendyl Magnuson and Richard Loucks to discuss how to set-up a better communication process with us before making changes to the Online Class Search site. Additionally, we will discuss how the FERPA requirements should be addressed when conducting our online classes.
- 5. The curriculum committee had to discussion of first draft of the proposed changes to the Distance Education Curriculum page until their next meeting.

6. I will be attending another a Can-Innovate session (online) on Wed, 10/16 with other regional hubs to discuss the plans for the upcoming on-campus "viewing session" conference. Palomar College will hold an all-day session "viewing session" at the Rancho Bernardo campus on 9/26

Najib and I are going to the South Center to check out the facilities for the conference.

7. Continuing to work through the problems with the Meta system concerning the DE approvals Lillian and I need to do. The system... shows that courses are not-pending, when they are (on the main Approvals page), both Lillian and I must approval each DE course (instead of just one of us), all courses show up for our approval (on the DE subcommittee) even if they are not DE courses... we have to go in and "approve" them with a comment that they are not really a DE course we just need to push them through the system.

Waiting for Cheryl Kearse to give alternate access to approving some DE courses that will not display the DE page properly in Meta.

8. I attended the monthly SDICCCA meeting Friday, 10/5 and discussed the Can Innovate efforts that they were undertaking. Palomar College is doing facilitating all three sessions in separate rooms, but most other colleges are one facilitating one of the three sessions.

I have been asked to write a @One blog post about the SDICCCA group and asked for suggestions from the other long-term members about what to include.

Palomar College seems to be ahead of most other colleges in terms of acting on promoting the Accessibility requirements to faculty. Southwestern college is just beginning to start this process as well.
