Order of March:	Travis Ritt indicated that Human Resources has asked the Senate for input on whether there is still a need to create the Order of March List. Each year during the graduation ceremonies, faculty tend to gravitate toward their general departments and overall the list is not structurally followed.				
	Senators discussed the list in terms of listing faculty retirees and faculty by years of service and that many faculty members may enjoy having this information. After some discussion, it was agreed that the list could be available for FACE and available for review on the district's website.				
Listing of Faculty in The Catalog:	Travis Ritt also indicated that members of Human Resources have inquired on whether there is a need to list Faculty Emeritus in the catalog. Senators questioned the need for a printed catalog in any capacity; noting that many colleges are moving to a completely online catalog due to environmental issues and to cut costs. Because the list has grown exponentially over the years and will continue to do so there was agreement that the list should be available for review on the district's website. Senate President Report:	Travis Ritt informed Senators that he shared the Senate's Resolution on AP 7120 (Hiring) at the November 13 Governing Board meeting. (III.A.1), III.A.7).		
	Also announced at the Governing Board meeting was that the Superintendent/President's Contract will be reopened and some of the language has been modified for clarity. The language that was modified was to state that the President's contract is a 4-year contract beginning in 2018, culminating in 2022. There was also clarification that the \$15,000 Annuity is a one-time payment.		
Palomar Faculty			
Federation (PFF):	Teresa Laughlin noted that faculty and PFF put some pressure on the district to do the right thing in terms of The Brown Act and are pleased that some progress has been made in relation to the Superintendent/President's contract. She said that Governing Board member Paul McNamara has requested that the issue be voted on by the new Governing Board when they are seated in December. Laughlin emphasized the importance of the community being able to see, hear, and participate in decisions made by the Board.
