Approval of Minutes:

Motion 1 MSC Thompson, Zavodny: Faculty Senate approval of the minutes of December 10, 2018,

as amended. The motion carried.

Public Comment: Senator Teresa Laughlin shared information from the Academic Senate for California

Community Colleges on The Brown Act as it applies to the meetings of all legislative bodies, and in this instance a reference to the Senate's Faculty Council. Laughlin noted that any additional meetings should be publicized. She also briefly outlined the role of the council as an advisory body to the Faculty Senate. In relation to Faculty Hiring, she said that according to Ed Code any changes to current policy on faculty hiring would have to

be mutually agreed upon by the Senate and the Governing Board.

Guest Susan Snow reiterated the role of the Faculty Council as advisory according to the Faculty Constitution. She asked the Senate to review the current language in relation to the Council. Both President Blake and the Governing Board need to be aware of the council's

role on the Senate.

Guest Barb Kelber reminded all that tenure comes with responsibility and an obligation to speak up. Tenured faculty have job security that many on campus such as deans and

administrators do not have. Faculty need to represent shared governance and the role of

faculty in that process.

Plan for 2018-19: This item will be postponed until the February 4, meeting.

New PRP Forms: Dean Smiley provided an overview of the revised Program Review & Planning (PRP)

process. Over the course of the past year, faculty have been asked to participate in the planning processes as a whole in hopes of streamlining the entire process. Working with Research & Planning has been useful as some specific sections on the forms are already in the system, and uses logic that will generate questions specific to your program or area. The data portion is not finalized, and Smiley said they continue to work and create training videos based on faculty input and useful information from previous PRP forms. Smiley said he hopes that the forms will be available for all faculty to submit by the end of the

semester. This item will be brought back for Faculty Senate Action at next week's meeting.

Distance Education: This will be discussed at next week's meeting.

Governing Board item to Create an ad hoc Committee addressing BP 2510:

Travis Ritt clarified his intention of bringing this item to the Faculty Council and President Blake as an opportunity for dialogue and a starting point to educate the board on the years of work by faculty on the current hiring process.

Discussion occurred on whether there was an intent by the administration to review and potentially amend BP 2510 before the next hiring cycle. Some present also asked for clarity on how that determination can be made and who makes it. It was noted that the Governing Board has purview over Policies & Procedures, though the current Policy on Faculty Hiring refers to following the Faculty Hiring Procedure. In order to make changes to the procedure it would have to go through the current shared governance process and there is not sufficient time to do that prior to this cycle of hiring.

When the procedure was last revised in 2015 it was with the reference to the Faculty Hiring Policy, which was also updated with language of diversity and a reiteration of the importance of consensus. It would benefit faculty and administration to share our current process of shared governance, in which faculty's role is assured by Palomar College's 10 + 1 + 1, and by the California Education Code.

There has been discussion over the past several years in how to attract a more diverse, expanded pool of candidates; including sending out the announcements earlier, expanding recruitment, and compensation at the first level, among others. Senators and guests said there needs to be more research done on the root cause of why it is so challenging to meet those expectations and what could be done to make those improvements. Some faculty pointed out that even with the changes in language in the Hiring Procedure there hasn't been a movement diversifying the faculty; and that, in turn, is an indictment on faculty. More has to be done.

There was also discussion on whether this Ad Hoc Committee to address BP 2510 is needed and if it does move forward, senators and guests cited the need for sufficient faculty representation. This item will remain on the Agenda for further discussion next week. 111.A.7 & 111.A.12

Senator Craig Thompson distributed information to Senators on the hiring process and the role in faculty hiring. He asked that it be brought forward for Faculty Senate Action at next week's meeting.
