Approval of Minutes:

Motion 1 MSC Thompson, Laughlin: Faculty Senate approval of the minutes of May 6, 2019, as

presented. The motion carried.

Vision for Success

Goals:

At last week's meeting, Senate members discussed the Vision for Success Goals, a response from a request from the Chancellor's Office to create aspirational goals as attempts continue to be made to close equity gaps for community college students.

Today, Michael Large was present to explain how the process of gathering data from various areas on campus occurred. Senators discussed how and why the Vision for Success goals were developed, and how faculty came to these numbers after reviewing data and the Chancellor's Office requirements. There were also comments made regarding the achievability of the goals as well as unknowns as it relates to accountability.

Motion 2

MSC Towfiq, Zavodny: Faculty Senate acceptance of the Vision for Success Goals. The motion carried. Nay: Fererro, Martin, Thompson. Abstentions: Dalrymple, Laughlin

Elections for Faculty Senate Vice President & Secretary:

Travis Ritt announced to the Senate that he will be stepping down as President at the end of the semester. He noted that he would remain on the Senate serving as past-president. The election will occur at next week's meeting to fill the remainder of Ritt's term. After brief discussion, Senators agreed that the elections to fill all of the positions should occur at next week's meeting.

Anastasia Zavodny asked that the Committee on Constitutional Review clarify the language in the Constitution as to whether or not part-time faculty can serve in the positions as Senate Vice President or Secretary prior to next Monday's meeting.

Motion 5 MSC Laughlin, Thompson: Faculty Senate approval of the granting of Emeritus Status to

Jon Stone, Professor, Trade & Industry, effective May 26, 2019. Stone has served the Palomar Community College district from August 24, 2001 to May 25, 2019. The motion

carried.

AB 705:

Shayla Sivert shared information on Assembly Bill 705/All About Me. The purpose:

- Increase the numbers of students who enter and complete transfer-level English and mathematics/quantitative reasoning in one year
- Minimize the disproportionate impact on students created through inaccurate placement processes
- Increase the number of ESL students completing transfer-level English within three years.

Sivert provided a short presentation on the overhead of AB 705. Students are no longer taking assessment testing, instead placement is determined by multiple measures. English, ESL, Math, and Reading have all adjusted their curriculum, providing students with support at all levels. An All About Me (Math/English 1st) webpage has been created to help students and answer questions about enrolling in English and Math courses (https://docs.google.com/presentation/d/15v_WWxQz-

<u>IbHzUkIuHeCKUMIXUCJbvUGfK3dtAuONT0/edit#slide=id.p</u>). A question and answer period followed.

Faculty Hiring:

Discussion continued this week on faculty hiring. Some guests and Senators shared their experiences working with Dr. Blake during the process. A robust discussion followed about the process, and some faculty expressed that they wanted to have more conversation with the President as to why or why not their candidates were hired.

Teresa Laughlin noted that the updated Faculty Hiring Procedure was unanimously supported by the Senate but it never made it through the administrative process. There was discussion on the need for consistency, collaboration, and consensus at every level. III.A.1, III.A.12

Senate President/ Vice President:

Notes from our meeting with Dr. Blake.

- A review of the budget and the new funding formula will be presented at a Town Hall Meeting before the end of the semester. The budget committee will have a retreat at the start of fall semester.
- The district is looking into developing alternative revenue sources through land leases at the Fallbrook campus to leverage our assets.
- Palomar College will honor a Valedictorian this year at graduation, Jose Miguel Chevalier, a military veteran student.
