CALL TO ORDER: The video conference meeting was called to order by Senate President Craig Thompson, at 2:30 pm.

PUBLIC COMMENT:

Hossna Sadat Ahadi announced that she, along with Luis Guerrero, will be facilitating a professional development ZOOM presentation on Friday, May 22, at 2 p.m. called Decolonizing Your Course Syllabus.

Jon Walker, ASG representative, thanked Senators for their efforts this year.

Senator Wendy Nelson stated that an emergency Faculty Senate meeting is needed to approve Distance Education curriculum items being presented this Wednesday, May 20, 2020. The emergency Faculty Senate meeting will take place this Friday, May 22, 2020 at 11 a.m. Fourteen Senators must be present for the quorum requirement.

Senator Lawrence Lawson noted that he did not see an HR item on the agenda today. Acting VP Linda Beam stated she would provide AP7120 feedback during today's Faculty Senate meeting.

Senator Lawson also reported that Policies and Procedures is going through a health fee revision addressing exemptions for students who are exclusively online. Right now, AP5030 reads that students don't have to pay health fees if they are taking a class online. This will be a problem since most classes will be online only in the Fall 2020 semester. Currently, students who are taking classes credit or non-credit at a site that doesn't have health services, don't pay the fees either. The committee will consider this area as well.

Senator Rocco Versaci announced that the Scholarly & Professional Achievement Award committee has four nominees and the award announcement will be forthcoming.

Senator Teresa Laughlin announced that PFF has recommended that Lawrence Lawson remain TERB Coordinator for another term.

Senate President Thompson acknowledged and welcomed new Senators.

E. Curriculum:

Senator Wendy Nelson reported that Curriculum is completing the emergency DE addendum for the state chancellor's office. The committee is adding a new emergency DE option into Meta that will not require the whole curriculum course review process. It should make curriculum approval easier. It will include a check box that says something like "can only be changed if there is an emergency." Senators questioned whether changing their courses to DE would mean they would have to teach the course online after the pandemic. Senator Nelson said the DE designation could be changed back in the same curriculum process. Nelson asked that faculty work on these changes in Meta over the summer to avoid a backlog in the fall. Senator Ellen Weller asked that the term "emergency" be further defined and clarified. Both Nelson and President Thompson are meeting with VP Sivert today and will bring up this concern.

F. Fall Online Teaching Certification:

Motion 11 MSC: Laughlin/Towfiq Faculty Senate approval to endorse the Chancellor's Office's decision of waiving online teaching requirements for summer and fall 2020.

"The Palomar Faculty Senate endorses the Chancellor's Office's decision to both waive online teaching certification requirements for faculty teaching online classes in the summer and fall along with its request that, despite this waiver, faculty make every effort to receive such certification before teaching online."

Senate President Thompson shared a draft endorsement that indicates Faculty Senate's support of waiving the online teaching requirements for faculty for summer and fall 2020. Thompson added that despite this waiver, faculty should make every effort to complete the certification process for teaching online as soon as possible. Erin Hiro, Senator and incoming DE Coordinator, said what is best for Palomar students is for faculty to complete the training in the summer so that they are ready to teach online this fall. ASG representative Jon Walker agreed with Hiro and encouraged faculty to obtain the POET training and online teaching certification during the summer to correct teaching issues he said students are currently experiencing in their online classrooms. Hiro, Thompson and Senator Wendy Nelson will be discussing this issue with VPI Shayla Sivert and said they will bring more information to the Senate's emergency meeting Friday.

The TEC members have the option to invite them, if needed. Lawson also told the Senate that he has noticed inconsistencies between the evaluations forms of faculty versus librarians and counselors. He said next fall he will propose adding contract and collegiality questions to counselor and library evaluation forms to make them match faculty evaluations. Lawson said he will bring this to TERB and to Faculty Senate for approval.
