I. Approval of Minutes:

IV. Fiscal Year 2014-15 Budget Information/Discussion

A. Distribute Budget Books - discuss

VP Perez distributed the 2014-15 Adopted Budget book and Phyllis Laderman presented an overview of the contents. She noted that the District did budget for restoration this year, which is not normally the practice. This is due to the fact that the opportunity to earn the restoration back is only available if we meet our FTES target level this year. In order to do this, we need to increase our FTES by approximately 500 to 19,317.

B. Review Annual CCFS 311 Report

Phyllis Laderman presented an overview of the CCFS 311 Report, which included the revenue, expenditures and fun balance data, as well as an analysis of PCCD's compliance with the 50% law. She discussed the background of the fifty percent law, which mandates that each community college district spends at least half of its "current expense of education" each fiscal year for salaries and benefits of classroom instructors and instructional aides. Discussion ensued.

C. FY2015-16 System Budget Request

VP Perez shared a Community College Update with the committee showing that the Board of Governors has approved the FY2015-16 System Budget Request. This budget request identifies four core priorities for funding: increasing access for community college students; funding for student success and equity; a COLA; and funding to hire more full-time faculty which were significantly reduced during the recent economic downturn.

V. Other

Theresa Laughlin asked if the South Center could be funded by reallocating \$2M of the annual Fund 69 contribution to a designated account for the South Center and then repay Fund 69 over 5 years at \$400K per year. She also would like to see if software licensing can come out of Fund 41. Finally, she would like to have the District run a scenario based on the following assumptions: Move Fund 69 balance of approximately 14M into the irrevocable trust to determine how this would affect the annual required contribution (ARC), currently at \$2.7M.

Shannon Lienhart asked that a list of designated accounts be brought to the next meeting.

There being no further business, the meeting was adjourned at 2:50 p.m.
