MINUTES

September 24, 2019

A meeting of the Budget Committee was held September 240, 2019, in Room AA-140. The meeting was called to order at 2:50 p.m. by Stephen Garcia, Acting Vice President of Finance and Administrative Services.

I. Approval of Minutes:

The minutes from the September 10, 2019 meeting were approved.

II. New Business

A. CAL-Cards

VP Garcia reported the number of CAL-Cards has been reduced significantly. Training sessions will be provided for staff and information will be available on the Palomar website. Division VP's are the ultimate approvers for all CAL-Card purchases.

B. FCMAT

VP Garcia reported the Fiscal Crisis Management Assistance Team (FCMAT) will be on campus Thursday, October 26^{th} to conduct interviews and gather information. FCMAT's Deputy Executive Officer, Michelle Giacomini, will give a presentation to the Governing Board at the September 24^{th} Board Workshop.

C. Enrollment Update

Kendyl Magnuson reported we are doing well with respect to headcount. State funded FTES if up 3.5% over this time last year. The two new centers, Rancho Bernardo and Fallbrook, have positive enrollment numbers, the Escondido Center is down slightly, the San Marcos campus is up slightly. He commented that growth is important, but the SCFF requires other criteria for funding. VP Garcia gave kudos to VP Kahn for his significant effort and support required for building enrollment so future funding can be for a large college, rather than a medium college.

D. Adopted Budget Revenue

VP Garcia and Carmen Coniglio gave a PowerPoint presentation, *Overview of Unrestricted Revenue Sources* \$163,348,843 Operational Budget.
