## **TESTING:**

The written exam takes place at San Marcos Public Safety Training Facility – 184 Santar Place, San Marcos, CA. Candidates with passing written exam scores will take the physical ability test immediately following the written test; please bring appropriate physical training attire.

## **EMPLOYMENT ELIGIBILITY:**

Immediate openings are available. Candidates with passing test scores will be placed on a candidate list for six (6) months, and may be extended. The candidate list will be available to participating San Diego North County fire agencies as a source for potential candidates for employment as a Firefighter/Paramedic.

**Cost:** No charge

**Requirement:**

1. Current California or National Registry Paramedic license.
