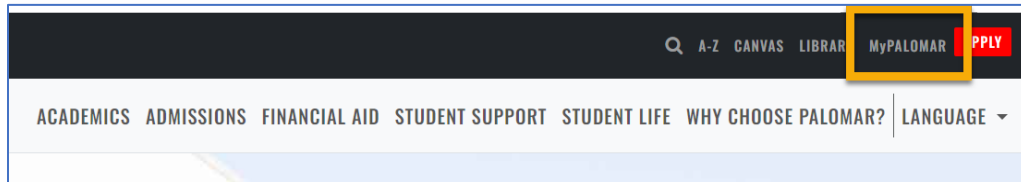

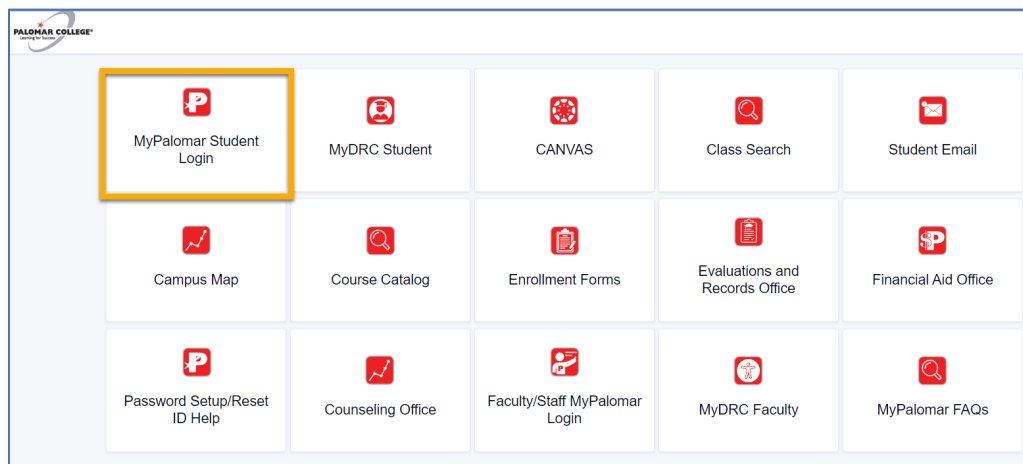

Instructions for Viewing and Printing the 1098-T

1. Navigate to Palomar.edu in your web browser.
2. Once on the Palomar website, click on "MyPalomar" in the top right corner of the page.



3. This will take you to a springboard with many options. Click on the MyPalomar Student Login in the top left corner.

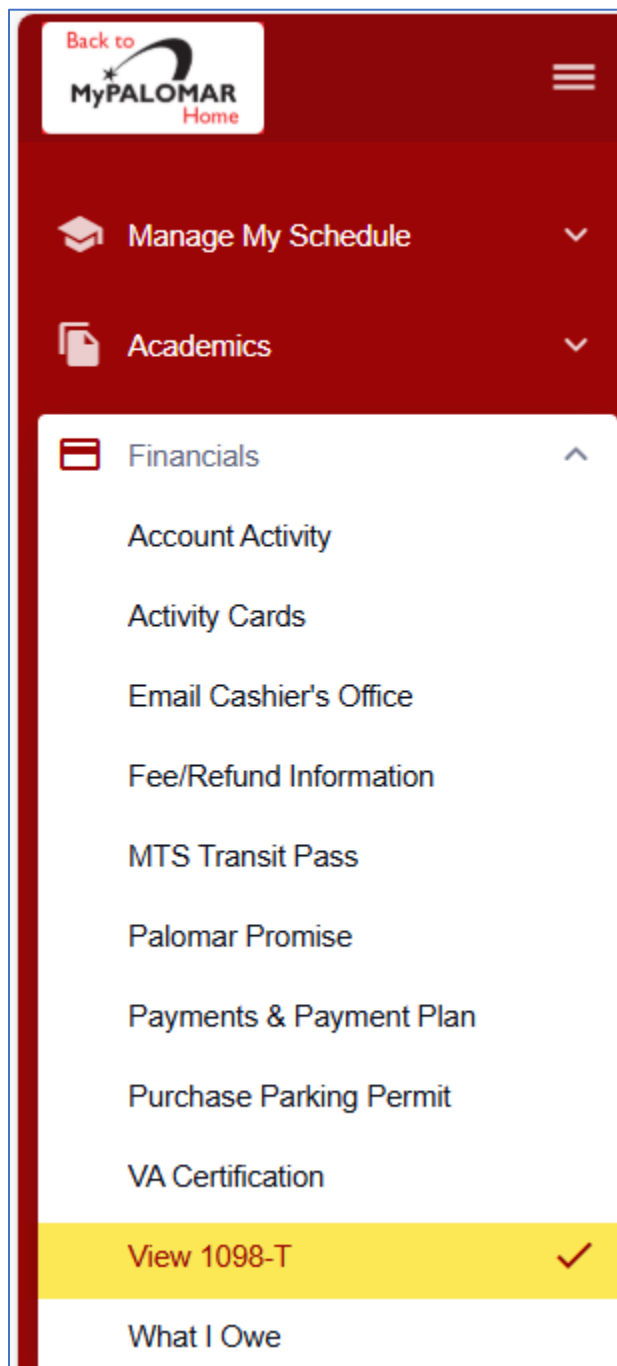


4. Enter your ID number and Password. Click Sign In.




