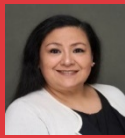

SPECIAL REPORT TO THE COMMUNITY

Public comments from the May 9, 2023, Governing Board meeting expressed concerns regarding the equity of part-time faculty pay. Another individual shared their concerns about the need to fill vacant classified positions and informed the Board that Classified Appreciation Week will be held starting on June 5, 2023. A retired classified employee will be partnering with the Council of Classified Employees (CCE) to develop a retiree group to support CCE efforts.
